Dear Budget and Assessment Field Staff,

As you know, in recent months the Department has been stepping up its efforts to acquire and maintain records and information related to how counties are administering the property tax system. As a part of these efforts, on September 26 the Department sent out a public information request to all County Auditors for copies of all executed contracts and agreements related to their current CAMA, property tax management software agreements and related support obligations. To date there are several counties that have not yet forwarded this information to us.

With this in mind the Operations Division, in conjunction with Budget Division Director John Mallers and Assessment Division Director Barry Wood, is asking for your help in assisting counties to deliver this information to us. After reviewing county assignments between the two divisions, we are asking specifically for your help with bringing one or two counties into compliance with this request. I have attached a spreadsheet that lists the assignments by field staff member. It is vital that we receive this information as quickly as possible; therefore, please work with your assigned county(-ies) to have these items forwarded to us **no later** than December 14th, 2007.

I have attached a copy of the letter which details the kinds of contracts and information we're requesting. The letter provides instructions on how counties can submit this information, either by mail or electronically, to the Department. If you have any questions about this request, please feel free to contact me at [tjorczak@dlgf.in.gov](mailto:tjorczak@dlgf.in.gov) and I will be glad to assist you.

Our apologies if you have forwarded the certification and election information to us in the last few days, as we are processing as quickly as possible. If you have sent the information for a particular County to DATA since 11/30/07, please disregard that County listing.
