ARTICLES OF AGREEMENT

This Contract entered into this Tuesday, May 15, 2001 , by and between Scott County Unit of Indiana, hereinafter referred to as the Scott County Unit and Government Finance Consultants, hereinafter referred to as GFC .

Whereas Scott County Unit has determined that they have a need for certain computer software, and

Whereas "GFC" has written and produced a software package described as follows:




Tax Distribution Form # 22

FORM22 is a database system designed to have the User enter each Taxing Unit's data, Fund Names, and other basic data only one time, and the Software will insert all the data in the proper locations of the Tax Distribution Form # 22.

FORM22 will print the completed Form 22 in a format essentially similar to the State Board of Accounts approved form.

FORM22 will also prepare and print the "Auditor's Certificate of Assessed Valuation" ready to mail to each Taxing Unit for their use in preparing their budget for the incoming year.

Scott County Unit is to pay GFC a fee of \$1,500.00 for the first year use of the Software.

- THIS FEE INCLUDES :
- A. Software License with support, updates, and training as needed .
 - B. First year Licensing Fee

Scott County Unit is to pay GFC a fee of \$300.00 for the second and future years.

- THIS FEE INCLUDES :
- A. Software License Renewal Fees, support as needed, updates, and all Software enhancements.



By accepting this Software Agreement Scott County Unit and GFC agrees to the following :

- This Software is licensed for use by Scott County Unit. The Software will be used only by the Licensee or his/her employees. No part of this software or the instructions shall be copied or reproduced by any means or given to any person or agency other than the licensee for use or review without the express written consent of Government Finance Consultants.
- No additional charges will be made to the licensee for travel or housing expenses due to program support or training, or installation of updates of the software purchased by this agreement.
- Annual license renewal and maintenance billing will be made in January of each year.
- Annual support payments are subject to the approval of the appropriating body and funding. Non-approval will terminate this agreement.
- Either party can terminate this agreement with ninety (90) days written notice.
- Upon termination of the contract, all Licensing will be null and void and "GFC" will remove the software from the Scott County Unit computers. Scott County Unit will retain ownership of all stored data.
- Any conversion of the data will be the responsibility of Scott County Unit.
- Response to requests for support typically will be made within four (4) hours, but always within 24 hours following receipt of the of the request for support.
