Dear Ms. Wolter:

Pursuant to IC 4-22-2-28, the Indiana Economic Development Corporation ("IEDC") has reviewed the economic impact analysis for small business associated with rule changes proposed by the Indiana Department of Local Government Finance ("DLGF") and contained in LSA Document 09-502. The proposed rule adds 50 IAC 27 to establish procedures and standards to govern local assessing officials and the DLGF in the annual adjustment of assessed valuations of real property. The proposed rule also deletes 50 IAC 14, 50 IAC 21-1, 50 IAC 21-2, 50 IAC 21-3, 50 IAC 21-5, 50 IAC 21-6, 50 IAC 21-7, 50 IAC 21-8, 50 IAC 21-9, 50 IAC 21-10, 50 IAC 21-11, 50 IAC 21-12, 50 IAC 21-4-1, and 50 IAC 21-4-2.

The economic impact statement prepared by the DLGF indicates that the proposed rule will not result in any economic impact to small businesses.
