IN THE MATTER OF THE REQUEST OF
THE BREMEN MUNICIPAL STORMWATER DISTRICT, MARSHALL COUNTY
FOR APPROVAL OF REFUNDING BONDS


A request was filed by the above named taxing unit for approval of bonds designated "Stormwater District Refunding Bonds of 2007" in the principal amount not to exceed \$1,220,000 maturing over a period ending no later than January 1, 2021, to provide funds to effect a savings to the District as it pertains to the refunding of its outstanding Stormwater District Bonds of 2000, and to pay the expenses in connection with the refunding bonds. After review of the request and supporting documentation and pursuant to IC 6-1.1-18.5-8 requiring approval of the Department of Local Government Finance, and all of the facts having been carefully considered, this Department does now take the following action thereon:

APPROVED:

Issuance of bonds designated "Stormwater District Refunding Bonds of 2007" in the principal amount not to exceed \$1,220,000 maturing over a period ending no later than January 1, 2021, to provide funds to effect a savings to the District as it pertains to the refunding of its outstanding Stormwater District Bonds of 2000, and to pay the expenses in connection with the refunding bonds. This approval is limited to the projects described in file 07-133 as presented to the Commissioner for consideration.

To obtain a debt service rate for 2007 pay 2008, the unit must comply with the provisions of IC 6-1.1-17-3. In addition, on or before December 31, 2007, the unit must execute the above issue and file with the Department of Local Government Finance a final amortization schedule.


