If the whereabouts of the above individuals or their successors is not determined by the conclusion of the informal hearing, it is the intent of the Division of Oil and Gas to reserve proceeds from the production of oil and gas from properties in which these individuals own and interest in the oil and gas, by integrating the oil and gas interests into a Production Unit established by the petitioners in the form of a proportionate 1/8th royalty interest of all oil and gas produced from the Unit.
