3. Bid Information

- -The bids are due in Indianapolis, as described in the NTB.
- -The bid opening is scheduled for Wednesday, September 21st, 2022 at 1:31 PM ET.
- -This project has an estimate over \$150,000; pre-qualification by Public Works in 1799.04 Mine Reclamation is required.
- -Pre-Qualification questions can be made to Tracy Cross with the Department of Administration, Public Works Division, at (317) 232-3255.

4. Contract Information

- -The contract will be paid utilizing federal AML grant reimbursement funds.
- Base bid quantities are identified in the specifications. The Schedule of Supplemental Unit Price Sheet must be submitted with the bid.
- -The 2022 AML Standard Specifications are located on the DNR AML Reclamation page: https://www.in.gov/dnr/reclamation/2477.htm
- A contract and purchase order may be in place within 8-12 weeks from the bid date.
- -The contractor must schedule a pre-construction meeting with the Division of Reclamation within 10 calendar days of the date on the notification to proceed prior to starting construction.
- -The **construction period** shall be completed by October 1st, 2023.
- -There is a **penalty assessment** for late completion at a rate of \$1,000.00 per calendar day.

- -The contractor is to include \$100,000.00 **remediation allowance** in the base bid for owner directed changes. This will be a line item on the schedule of values.
- –Minority and Women Business goals have been established and are identified in the NTB.
- AVS Checks will be performed on the low bidder to ensure no negative history in the federal mine database (bond forfeitures and outstanding violations)

5. Brief Project Description

Clear and grub, backfill highwalls, eliminate dangerous piles and embankments, improve drainage, and revegetate site to enhance wildlife habitat and recreation opportunities.

Do you anticipate double handling of materials will be an issue?	Double handling of materials should be minimal. Unsuitable material areas are designated on the plans if issues arise. The contractor will work with the project manager to keep these issues to a minimum.
Loose fill	4 feet, 1 pass with low ground pressure dozer.
Special requirements for muck?	Trap and bridge if possible. If it is not possible it will need to be dried and spread.
Is there a beaver exclusion fence required?	Yes, see plans located at: www.in.gov/dnr/engineer/2908.htm .
Rock pile disposal?	Disposal locations should be discussed with the project manager.
Stump disposal?	If stumps are in place and under 4 feet of fill, they can be buried. If they are not in place they will need to dispose in stump piles. Stump pile locations are noted on the plans and should be coordinated with the project manager.
Survey Controls before the project?	Yes we will provide
Road bond?	Not needed on state highway.
End date?	The end date is October 1, 2023.
Will the contractor receive a receipt after submitting their bid electronically as directed in the NTB?	No, you will not receive a receipt of bid submittal. Bidders should maintain their own record of bid submittal confirming it was sent to the appropriate address detailed in the NTB.
What is the total acreage of this project?	70 acres
Bat habitat?	NO clearing between April 1 st and October 1 st .
Driveway permit?	NO, we don't believe one is needed. If one is needed reclamation will provide.
