

**COST-SHARE, FLAT-RATE AND INCENTIVE PRACTICE RATES FOR
WATERSHED LAND TREATMENT (WLT) PROJECTS**

**LAKE AND RIVER ENHANCEMENT (LARE) PROGRAM
INDIANA DEPARTMENT OF NATURAL RESOURCES
DIVISION OF FISH AND WILDLIFE**

Lake and River Enhancement (LARE) is a stand-alone program for cost-share purposes. “Cost-share” or “flat-rate” practices will not be eligible to receive payments from LARE if they are combined with any local, state or federal program.

“Incentive” payments are independent of “cost-share” or “flat-rate” payments and may be combined with non-state incentive or rental rate payments.

INCENTIVE PAYMENTS

<u>PRACTICE</u>	<u>INCENTIVE PAYMENT</u>
<u>Critical Area Planting</u>	\$450 per acre
<u>Tile Riser Grassed Buffer</u>	\$250 each
<u>Blind Tile Inlet</u>	\$500 each
<u>Watercourse Outlet Buffer</u>	\$125 each
<u>Filter Strip</u>	\$650 per acre (maximum of 60 feet wide)
Appropriate widths will be based on selected purpose(s) from NRCS standard - Filter Strip (393)	

FLAT-RATE PRACTICES

Flat-rate payments will be authorized for the following practices within the watershed **and are not eligible for funding if cost-shared with any other local, state or federal program.**

Cost-sharing shall consist of the following flat-rate payments with a maximum of 300 acres/year and shall not be made available to any landuser for more than three years:

Eligible Practices	Flat-Rate payment (per acre) applied anywhere within the watershed.
Conservation Tillage-No-Till	\$20.00

Cover Crop	\$35.00
Integrated Crop Management	\$20.00

COST-SHARE PRACTICES

Cost-share for tile installation in conjunction with all practices will be limited to an 8” diameter tile (or equivalent cost) unless prior approval is obtained. When practice installation requires tile(s) larger than 8”, prior approval of the IDNR LARE project manager must be obtained. **Cost-share practices shall not be eligible for funding if cost-shared with any local, state or federal program.**

The following practices will be cost-shared at 80% of the actual cost of installation and shall not exceed the maximum cost-share amount:

<u>Fencing</u>	\$2.50 per foot

<u>Grade Stabilization Structure</u>	\$6,000 per structure
<u>Grassed Waterway</u>	\$6.00 per foot
<u>Heavy Use Area Protection</u>	\$1,500 per site
<u>Livestock Watering Facility</u>	\$1,500 per facility
<u>Livestock Watering Impoundment</u>	\$5,000 per facility
<u>Pasture and Hayland Planting</u>	\$150 per acre
<u>Sediment Basin</u>	\$3.00 per cubic yard
<u>Streambank Protection</u>	\$50.00 per foot
<u>Tree Planting</u>	\$450 per acre
<u>Waste Management System</u>	
Containment system	\$20,000 per facility
Waste utilization	\$0.01 per gallon

	\$2.50 per ton

<u>Closure of Waste Storage Facility</u>	\$10,000 per facility
<u>Water and Sediment Control Basin</u>	\$1,700 per basin
<u>Wetland Development & Improvement</u>	\$1,000 per acre

Cost-Share Partial Payment Policy

A cost-share construction project may receive partial payment if the project cannot be fully completed due to weather constraints and/or cropping conflicts. At the time of construction termination, the partial construction must be at a stable and sensible separation point for the practice, based on sound engineering and environmental principles. Temporary erosion control measures must be applied, if necessary, for project stabilization. Approval for partial payment must be made by the Lake and River Enhancement Section Chief or approved staff person before an agreement is made regarding partial payment with the cost-share participant. LARE will pay 90% of the earned cost-share, holding 10% until the project is fully completed.

For example:

1. A grassed waterway construction that is completed after standard seeding dates in the fall may be seeded with a temporary seeding mixture and approved for 90% payment of the earned cost-share. The withheld 10% of the earned cost-share, along with the remaining project cost-share, will be paid when a permanent seeding mixture is applied and the project is completed.
2. A tile installation that is completed for a WASCOB may receive payment for 90% of the earned cost-share; the withheld 10% of the earned cost-share, along with the project's remaining cost-share, will be paid after the WASCOB construction is complete.
