Land and Water Conservation Fund (LWCF) Map Criteria Revised 8/2023



Location Map(s)

The location map(s) shows the project property in reference to the surrounding area. This map may be a county/city/town map with the *project location and entrance* identified. A second (zoomed in) map may be included to help staff find the property without needing to ask directions.

LWCF Boundary Map(s): 6(f) boundary/federally protected area boundary

Items to consider:

1) Exclude indoor recreation facilities and/or any facilities that are not eligible for LWCF funding (e.g., senior centers, cell towers, community centers).

2) Leave room for expansion of adjacent roadways or other nonrecreational facilities (i.e., show the 6(f) boundary approximately 20 feet inside of property lines if it is along a road that may be widened).

The LWCF boundary map is specific to the project area. It <u>must</u> contain:

- 1) Official park/site name
- 2) Location/complete address
- 3) Park entrance location(s) with latitude and longitude
- 4) County, Township, Range, and Section number
- 5) Name of person/agency preparing the map
- 6) Date
- 7) LWCF Project Number
- 8) ASLO signatory with date DNR will add
- 9) North arrow
- 10) Map Legend
- 11) Total acreage of existing park
- 12) LWCF project boundary
- 13) Sufficient detail to legally identify the lands to be subject to the provisions of the LWCF Act. Acceptable methods of identification include:
 - a. Deed references
 - b. Adjoining ownerships, easements, and rights-of-way
 - c. Public streets
 - d. Adjoining bodies of water or other natural landmarks
 - e. Metes and bounds or surveys
 - f. Where one or more of the above methods are not readily suited for identifying the area, measurements from permanent locators may be used

- 14) All known outstanding rights and interests in the area held by others.
- 15) Known easements, deed/lease restrictions, reversionary interests, etc. are to be documented
- 16) Any area(s) under lease, name(s) of lessor and lessee, and term remaining on the lease(s)
- 17) Information relating to environmental review
 - a. Floodplains
 - b. Bodies of water and/or wetlands
 - c. Sensitive natural areas and/or features
 - d. Areas to be impacted by habitat improvement (e.g., invasive species removal or prairie plantings)
- 18) All new development included in the LWCF application
- 19) All existing features including:
 - a. Structures
 - b. Park Roads
 - c. Parking Lots
 - d. Recreation activity areas (ball fields, picnic areas, etc.)
 - e. Enclosed structures/buildings
- 20) Locate all utility lines
 - a. Specify
 - i) Whether they are overhead or buried
 - ii) Which overhead wires are proposed for burial
 - b. ID any high voltage transmission lines that cannot be buried
 - c. ID any transformers or substations on the site
- 21) Locate any other outstanding rights and interests such as:
 - a. Gas, water, or sewer lines
 - b. Dedicated drainage ways
 - c. Railroad tracks
 - d. Billboards
 - e. Deed/lease restrictions, reversionary interests, road ROW setback
- 22) Identify any other improvements or features such as
 - a. Wells
 - b. Septic systems
 - c. Water towers
 - d. Transmission towers

Avoid use of color as the only means to delineate areas. Hashed polygons (or other shapes) are acceptable.
