



## **Instructions for Completing Motorsport Investment District Vendor Form**

I.C. 4-10-23 as added by P.L. 233-2013 requires the Indiana Department of Revenue to compile and report the amount of state retail sales tax and state adjusted gross income tax attributable to activities within the Motorsports Investment District that contains the Indianapolis Motor Speedway. The allocation of adjusted gross income tax payments attributable to activities within the District will be based on the duty days calculations specified in I.C. 6-3-2-3.2. In order to provide for the required duty day and tax payment information, I.C. 4-10-23-9(c) states that "Businesses operating in the district shall report, in the manner and in the form prescribed by the department of state revenue, information that the department determines necessary to calculate incremental gross retail, use, and income taxes." This informational return constitutes the manner and form prescribed by the department.

The information reported in Section 1 is to include only withholdings from income earned while working in the Motorsports Investment District and retail sales tax collected on sales made in the Motorsports Investment District.

For section 2, only list contractors engaged to perform vendor services within the Motorsports Investment District.
