Pursuant to the Worker Adjustment and Retraining Notification Act ("WARN"), we regret to inform you that OFS Brands Holdings, Inc. will terminate the employment of employees at its OFS Brands Plant 8 facility located at 1008 North Chestnut Street, Huntingburg, IN.

This action is expected to be PERMANENT in nature. This action is due to the closure of Plant 8, as a result of the consolidation and relocation of Plant 8's business operations to other OFS Brands case goods manufacturing sites. The entire Plant 8 will be closed due to this action. There may be certain employees at Plant 8 who are offered the opportunity to transfer to other OFS locations depending on the availability of open positions at said locations and the work history and skill set of each affected employee versus the skill set(s) in demand.

The employment terminations are expected to commence on March 23, 2009 with the last day worked March 23, 2009 (or on a date within the 13-day period immediately following March 23, 2009).

The number of workers who hold affected jobs in each job classification, the job titles of the affected positions, and schedule of separations are as shown on Exhibit "A" which is attached and made a part of this notice.

OFS Brands Plant 8 employees are all non-union employees and have no bumping rights. Seniority will not be the determining factor of retention.
