Re: Notice of Planned Action under the Worker Adjustment Retraining Notification Act

Dear Sir or Madam,

I write on behalf of Five Star Senior Living Inc. (the "Company") to alert you that a decision has been made to permanently close the healthcare unit (the "Healthcare Unit") located within Meadowood Senior Living, located at 2455 Tamarack Trail, Bloomington, Indiana 47408. Over the next several weeks, we will work closely with Healthcare Unit residents, their responsible persons and families to develop and execute individual transition plans, submit required notifications and closure plans to the state department of health and local ombudsman and take all other necessary steps to permanently cease operations within the Healthcare Unit (the "Closure Process").

We expect employment separations to begin on May 1, 2021. The separations may come in stages, depending upon our needs throughout the Closure Process. We expect that all separations will be accomplished by not later than July 5, 2021. Attached is a list of the job positions and number of individuals who will be affected by the closure of the Healthcare Unit.

The Company does not recognize strict seniority rights in connection with its separation decisions, but may take seniority into consideration as a factor in determining which employees to terminate and the timing of each employee's separation date. Bumping rights do not exist. To our knowledge, the affected employees are not represented by a bargaining unit or union representative.
