## Re: Announcement of Planned Action

To Whom It May Concern:

I am writing on behalf of Trialon Corporation ("Trialon") to give you notice that there will be a mass layoff at the Kokomo Morgan Street facility at 1501 County Road East 200 North in Kokomo, Indiana beginning on October 22, 2023. The facility is owned by Trialon's client, BorgWarner PDS (USA) and will involve Trialon employees. This mass layoff is expected to be permanent. We are providing you with this notice in accordance with requirements of the Federal Worker Adjustment and Retraining Notification Act (WARN).

All affected employees have been notified as of August 23, 2023, of their anticipated separation dates and that their separation from employment is expected to be permanent, with the estimated date of separation to be October 22, 2023.

The total number of Trialon employees who will be affected by this facility closing is Attached is a list of the job positions and number of individuals who will be affected by the mass layoff, along with the anticipated schedule for job losses.

There will not be any bumping rights for the affected employees, that is, employees will not be able to displace more junior employees out of their job positions as a result of this mass layoff. There is no union representing impacted employees.
