## **INDOT Pinpoints 22 Projects in 17 Counties for ARRA Funding**

*Estimated Cost of Projects is \$54 Million*

**INDIANAPOLIS** – INDOT has identified 22 projects in 17 counties that are being advertised for funding through the American Recovery and Reinvestment Act. The estimated cost of the projects is slightly over \$54 million.

“This is the third list of projects INDOT has let for bids,” said Mike Reed, “and we continue to follow Governor Daniels’ mandate of moving as quickly as possible to create jobs for Hoosiers all across the state.”

President Barack Obama signed the American Recovery and Reinvestment Act into law on February 17 in an effort to create jobs and stimulate the economy.

It allocates \$657 million to Indiana for highway, bridge and transportation enhancement projects. Of that amount, \$440 million has been set aside for state projects, \$198 million for metropolitan planning organizations (MPO) and other Local Planning Agencies (LPA), and \$20 million for transportation enhancement projects, such as hiking and biking trails and sidewalks.

Projects that can be funded through the ARRA must be “shovel ready.” That means all the details of the project from plans to specifications to cost estimates, as well as right-of-way and environmental mitigation, must be complete.

Once a project is submitted by an MPO or an LPA, it is reviewed by INDOT for accuracy. Then, the Federal Highway Administration reviews the project to make sure it meets federal guidelines for constructing highways.

Funds for projects that clear both reviews are then set aside, and the projects can be advertised for bids.

Projects will range from road resurfacing and pavement preservation to bridge deck overlays, bridge deck replacement, bridge painting, as well as highway safety improvements, such as traffic signals.

All state and local projects must have funds set aside by March 3, 2010, and the work on those projects must be completed by February 17, 2012, according to ARRA guidelines.

The bids on the April projects will be opened April 22.

To date, INDOT's three ARRA funding lists that total 73 projects in 46 counties. The total value of the projects is \$122.8 million.

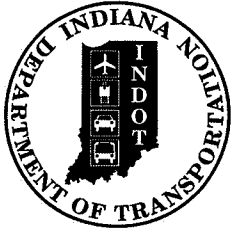
