



House Rule: Recency Requirements for Horseshoe Indianapolis | This House Rule will supersede IHRC Regulation 71 IAC 7.5-4-1 as it applies specifically to a horse that has not started for a period of two hundred & forty (240) days or more. A horse that has not started in the previous 240 days is not eligible to start at Horseshoe Indianapolis until it has successfully completed a racing soundness examination administered by the Regulatory or Track Veterinarian. If the Regulatory or Track Veterinarian conducting the racing soundness examination finds the results of the examination to be unsatisfactory or inconclusive as to the racing soundness of the horse, the Veterinarian may, at his/her sole discretion, place the horse on the Veterinarian's List & establish conditions for removal from the list including, but not limited to, laboratory testing of biological samples & an official workout of a specified distance completed within a specified minimum time.

ATTENTION TRAINERS: Please make certain you, your owners & your employees have completed the Indiana Horse Racing Commission licensing process for 2023. In addition, please be aware that the entire ownership for your horse(s) racing must be taken care of prior to race day. Indiana does not have a temporary license (as in other jurisdictions) & they have limited hours. IHRC direct dial (317.713.3350).

Thoroughbred trainers are strongly encouraged to send two (2) attendants with each horse that is required to go to the IHRC Test Barn.
