1 1:08 o'clock p.m. July 21, 2023 2 3 VICE-CHAIR RAMOS: I'm calling the 4 meeting to order July 21st, and we just heard a 5 beep. Is that anything? 6 MR. LOSTUTTER: We're unmuted there 7 SO 8 VICE-CHAIR RAMOS: Oh, okay. 9 MR. LOSTUTTER: -- people can hear 10 us. 11 VICE-CHAIR RAMOS: All right. 12 So, we have a fairly easy agenda today. 13 This is Vice-Chair Ramos, for the record, and our 14 Chair is on the phone and driving out east. 15 So, thank you for joining us, Chair Slash. For our agenda today, would you go ahead 16 17 and announce our agenda for the meeting? And we 18 do have a quorum. 19 MR. LOSTUTTER: Good. All right. 20 And the agenda that we have is a very light one: 21 Approval of previous meeting minutes, the monthly 22 ICRC records report, and then we will have Old 23 Business, Commissioners who were appointed to

8	VICE-CHAIR RAMOS: Thank you.
9	Hearing that, let's move to approving the
10	previous meeting minutes. We'll need to take
11	roll call. I need a motion to approve.
12	COMM. TOLLIVER: So moved.
13	VICE-CHAIR RAMOS: I need a second.
14	COMM. SILBERBERG: Second.
15	VICE-CHAIR RAMOS: All those in
16	favor, David I'm sorry Michael?
17	MR. LOSTUTTER: Michael.
18	All in favor of approving last month's
19	meeting records, say aye.
20	COMM. SILBERBERG: Aye.
21	VICE-CHAIR RAMOS: Aye. You need to
22	do a roll call.
23	MR. FLEISCHHACKER: Yeah, you need to

do roll call. 1 2 MR. LOSTUTTER: Okay. 3 Chair Slash? 4 (No response.) 5 VICE-CHAIR RAMOS: Did we lose her? 6 Are you there still, Adrianne -- I'm 7 sorry -- Chair Slash? 8 (No response.) 9 VICE-CHAIR RAMOS: Chair Slash? 10 CHAIR SLASH: I'm sorry. VICE-CHAIR RAMOS: We just made a 11 12 motion to approve the agenda. 13 CHAIR SLASH: Aye. 14 VICE-CHAIR RAMOS: Aye, we have an 15 "aye" from Chair Slash. 16 MR. LOSTUTTER: Chair -- or 17 Comm. Silberberg? 18 COMM. SILBERBERG: Aye. 19 MR. LOSTUTTER: Comm. Tolliver? 20 COMM. TOLLIVER: Aye. 21 MR. LOSTUTTER: Vice-Chair Ramos? 22 VICE-CHAIR RAMOS: Aye. 23 All right. We'll move on to the

1 Director's Report.

2	MR. FLEISCHHACKER: Thank you,
3	Vice-Chair Ramos. We've had a busy last month
4	and a half. We had the ICRC Civil Rights
5	Conference in mid-June that went extremely well,
6	had a lot of great speakers, a lot of great
7	events, was well attended. We had close to 350
8	in person and a similar number, 350, 400, joining
9	us virtually as well. So, we've heard really
10	positive feedback about the Conference and about
11	the content that was shared, so we feel really
12	good about the product that we put out and had
13	people engage in, and our staff here did a
14	phenomenal job of putting that together and
15	engaging in that. So, that was a great success
16	and accomplishment for the Commission.
17	And then I recently had a number of events
18	associated with Summer Celebration for Indiana
19	Black Expo. The Governor's Reception, where we
20	hand out and recognize a number of community
21	leaders, and then also handed out our Harold
22	Hatcher Award for a staff member, and that went
23	to Fred Bremer this year, a well-deserving

individual, an attorney who's been with the Commission for longer than the Indiana Fair Housing Act has been around, so that's a testament to his commitment to civil rights here in the State of Indiana. So, that was a great recognition for him.

7 A couple of upcoming things: We continue to do CORE. We have CORE coming up the first 8 9 week of August, and then I think some calendar 10 reservations went out, at least to the staff, 11 hopefully to you as well, if not we'll get them 12 on your calendar, but on September 19th and 20th 13 are going to be our Days of Service for this 14 year, where we go out into the community and do 15 some beautification projects and work with a 16 number of agencies and a number of other entities 17 out in the public to make those happen, but those are the dates that those Days of Service are 18 19 scheduled for.

As far as projects go, ongoing stuff, Genesis and CMS continue to be viable products and assisting us in doing some of our work. Obviously, as with any technology, there's some 7

1 bumps along the way that we're working through on 2 some of those, but overall, especially with Genesis, and then as we're starting to get into 3 4 our Power BI reports and so for CMS, those will 5 definitely assist in our reporting capabilities 6 and tracking capabilities for the things that are 7 in each of those systems. 8 Our Fair Housing testing is ongoing. 9 We've -- I think I reported last month that we've 10 got ten Director-initiated complaints that are in 11 process right now, and a number of which, the 12 entities have indicated a desire to engage in 13 settlement discussions to resolve those, so 14 hopefully we can bring those to a conclusion and 15 assist those entities in changing their practices 16 and policies to ensure that they're adhering to 17 the Fair Housing Laws. We -- at the end of June, we completed our 18 19 HUD contract for this last cycle, and it was 20 another successful year. It looks like we'll end 21 the year at around 165 cases, and last year we 22 ended that contract year at 168, so right around 23 the same number that we did the prior year, and

1 this year we didn't really have any testing cases 2 in, just based on how the testing played out. So, a great job with our Intake staff, REPACE 3 4 staff, and everyone involved in moving those 5 along, getting those resolved and investigated 6 and played out. 7 So, the EEOC contract ends at the end of 8 September, that's when that fiscal year ends and 9 when that contract period ends, and we're on 10 track to meet our -- the EEOC contract was 11 for 350 cases, and we're on track to meet that, 12 and we have close to 400 current files that are 13 in our office to be investigated, so we're well 14 positioned to meet that same contract for next 15 year already. So, good things going on in those 16 areas. 17 As far as some metrics go, year to date 18 for 2023, we've recorded 4,968 calls into the 19 agency into our queues, and that's an increase 20 from 1,819 last year during that same time 21 period, but again, a lot of that is a byproduct

of Genesis and being able to better track the

calls that are coming in.

1	As far as inquiries go, we've had 1,417
2	inquiries through the end of June, compared to
3	1,031 in the same time period last year; that's a
4	37-and-a-half-percent increase. We've formalized
5	586 complaints through the end of June, so at the
6	half-year mark, compared to 345 the year last
7	year; that's a 70-percent increase, so we're
8	looking to possibly eclipse the thousand mark on
9	formalized complaints for 2023 if that trend
10	continues.
11	And then so far in 2023, or through the
12	end of June, we've had over \$472,000 in monetary
13	relief through our resolved settlements, compared
14	to 423,000 in the same time period last year, so
15	an eleven-and-a-half-percent increase in our
16	monetary awards.
17	I always like to point to our inquiry
18	our percentage of inquiries that result in formal
19	complaints. In 2023, for the first half of the
20	year, we had a 41-percent rate of inquiries being
21	turned into formalized complaints, compared to 34
22	percent in the same time period last year.
23	And then at the end of June, we had 49
l

1	open litigation cases, compared to 75 at the same
2	point last year. However, I just you know,
3	prior to the meeting, I mentioned closing 45 or
4	so notices of findings. Eight of those, however,
5	were cause cases, so those will get added into
6	our open litigation files. We've closed a
7	couple, so we'll be in the low to mid 50's as far
8	as open litigation cases, likely, for the end,
9	once the end of June comes about.
10	So, a lot of great work going on. I think
11	I say that every month. We're getting a lot of
12	people coming into the office and contacting us
13	about things going on in their lives. I think
14	that's a testament to the heightened awareness
15	that we have going on, getting our name out, and
16	I think anecdotally, probably some, you know,
17	return to pre-COVID kind of workplace scenarios
18	and housing scenarios.
19	So, I think a lot of those different
20	things are working together to increase the
21	amount of people and the amount of traffic that
22	we're having come into the agency. And then our
23	staff are doing a great job of getting that work

done and moving cases through in a timely manner. 1 2 VICE-CHAIR RAMOS: Thank you, Deputy 3 Director. I've heard nothing but phenomenal 4 things about that, you know, the Housing 5 Conference that you had. It was, you know, 6 fantastic. I participated in some of it, and I 7 know I also received an invitation for the Women's Commission Awards Dinner that's coming up 8 9 here. 10 MR. FLEISCHHACKER: Yeah, their 11 Torchbearers, I think, is sometime in September 12 as well, so that event's coming up, yep. 13 VICE-CHAIR RAMOS: That's great. So, 14 I commend the office. You're doing a great job, 15 and everybody is right on track and we're ahead of everything from year to year, so that's 16 17 fantastic. 18 Commissioners, comments? 19 (No response.) 20 VICE-CHAIR RAMOS: Okay. So, we 21 will -- thank you, again, very much. We will 22 move on to the next order of business. That's 23 old business. Comm. Tolliver, you had the case

1 of Scott Gribbons versus Henry County Planning 2 Commission, Case No. HOha23020175. 3 COMM. TOLLIVER: Yes. There are 4 three issues, and I recommend that we approve the 5 Commission's finding of no reasonable cause under 6 the Indiana Fair Housing Act, and no probable 7 cause under the Indiana Civil Rights Act for 8 issue one. Do you want me to do all three 9 issues? 10 VICE-CHAIR RAMOS: You can do them 11 all together. 12 COMM. TOLLIVER: The second issue 13 would be the same, no reasonable cause under the 14 Indiana Fair Housing Act, and no probable cause 15 under the Indiana Civil Rights Law. And then on the third issue, no reasonable 16 17 cause under the Indiana Fair Housing Act, and no 18 probable cause under the Indiana Civil Rights 19 Law. 20 VICE-CHAIR RAMOS: I need a motion to 21 approve. 22 COMM. SILBERBERG: Motion to approve. 23 VICE-CHAIR RAMOS: I'm -- I can

SILBERBERG: So moved. 7 VICE-CHAIR RAMOS: I need a second. COMM. TOLLIVER: Second. 8 9 VICE-CHAIR RAMOS: Those in favor? 10 MR. LOSTUTTER: We will call the 11 roll. Chair Slash? 12 13 CHAIR SLASH: Chair Slash, aye. 14 MR. LOSTUTTER: Comm. Silberberg? 15 COMM. SILBERBERG: Aye. 16 MR. LOSTUTTER: Comm. Tolliver? 17 COMM. TOLLIVER: Aye. 18 MR. LOSTUTTER: And Vice-Chair Ramos? 19 VICE-CHAIR RAMOS: Aye. 20 MR. LOSTUTTER: The ayes have it. 21 VICE-CHAIR RAMOS: There are no other 22 Motions or Other Filings. Tolliver. 5 The next case is Jesse Rider versus Herman 6 and Kittle Properties and Lynhurst Park 7 Apartments, Case No. HOha23020142, and I'll 8 assign that to Comm. Silberberg. 9 COMM. SILBERBERG: I may not be at 10 the next meeting --11 VICE-CHAIR RAMOS: Okay. 12 COMM. SILBERBERG: -- but I can take 13 it and give my recommendation. 14 VICE-CHAIR RAMOS: Provide the 15 recommendation? Yeah, if you're okay with that. COMM. SILBERBERG: 16 Yes. 17 VICE-CHAIR RAMOS: Thank you very 18 much. 19 And the last case is Rachel Godley versus 20 FCA (Chrysler) US LLC's Kokomo Engine Plant. 21 Case Number is EMra22120710, and I'll assign that 22 case to me. 23 Then the next item is Motions and Other

1 Filings, and we have none. 2 The next item on the agenda is Review of 3 ALJ Decisions and Orders, and we have none. 4 And the next section is ALJ Decisions 5 Automatically Confirmed. Again, there are none 6 on the agenda. 7 Which takes us to the meeting dates for 2023. Our next scheduled meeting is 8 9 August 18th. 10 Do we have any conflicts, Commissioners, 11 with August 18th? 12 COMM. SILBERBERG: I --13 VICE-CHAIR RAMOS: Will you be able 14 to attend virtually, or --15 COMM. SILBERBERG: I'm not sure that I will. I will do my best, but that's not a good 16 17 day that day. It's problematic because of the 18 Sabbath and when it falls and everything. 19 VICE-CHAIR RAMOS: Okay. Understand. 20 Chair Slash, will you be able to attend on 21 the 18th of August? 22 CHAIR SLASH: Yes, I will. 23 VICE-CHAIR RAMOS: Looking at

1 September 15th, that's in the middle of 2 September. Are there any conflicts anyone has 3 with the 15th? 4 COMM. SILBERBERG: That is the day 5 before Rosh Hashanah, so I will not be there. 6 VICE-CHAIR RAMOS: Okay. All right. 7 So, we'll just work with the other Commissioners to see if they're able to --8 9 COMM. SILBERBERG: When -- we had 10 talked about -- oh, I'm sorry. 11 VICE-CHAIR RAMOS: Go ahead. COMM. SILBERBERG: -- about moving 12 13 those -- about moving to a different day. 14 Wouldn't it be by then? 15 VICE-CHAIR RAMOS: We would -- you know, we'll make that determination next month if 16 17 we have other conflicts as well. I can 18 appreciate that, that there may be a conflict for 19 others. I'm -- personally, I need to leave the 20 week after that for three weeks, so it wouldn't 21 be -- work for me, but let's figure that out next 22 month. 23 The next item is -- there is no Election,

1 Training or Other. 2 Are there any announcements? 3 (No response.) VICE-CHAIR RAMOS: No announcements. 4 5 Are there any public comments? 6 (No response.) 7 VICE-CHAIR RAMOS: No public 8 comments, so it is --9 COMM. TOLLIVER: Before we adjourn, 10 can I ask to change my vote on LaToya Richardson 11 versus IUPUI? I think out of an abundance of 12 caution, I should recuse myself since I teach 13 there. 14 VICE-CHAIR RAMOS: We do not have --15 we do not have a majority --16 MR. LOSTUTTER: I mean we -- that 17 would have an impact, I believe, on the outcome 18 there, because we --19 COMM. TOLLIVER: A recusal? 20 MR. LOSTUTTER: Well, we would have 21 to --VICE-CHAIR RAMOS: We don't have a 22 23 majority --

MR. LOSTUTTER: Yeah, we have to hold 1 2 off on making a final decision, I believe, until 3 next month, if we --4 COMM. TOLLIVER: Yeah. I just don't 5 think I can vote on that. 6 VICE-CHAIR RAMOS: Okay. All right. 7 So, for the record, Case No. EDra22110652, which is LaToya Richardson versus Indiana 8 9 University and Purdue University Indianapolis, 10 Comm. Tolliver is citing a conflict of interest; 11 is that how --12 COMM. TOLLIVER: Yeah. 13 VICE-CHAIR RAMOS: And so -- and 14 recommends, for all of the right reasons, to 15 recuse his vote. That does not provide us a 16 majority to pass the motion, so we will defer 17 that decision until the August Commission 18 meeting. 19 COMM. TOLLIVER: Thank you. 20 COMM. SILBERBERG: Yeah, and 21 actually, I can't be there, like I said. 22 VICE-CHAIR RAMOS: Okay. Well, since 23 it's back on the docket, we should be okay. We

1 just need to make sure we have enough votes --2 MR. LOSTUTTER: Yes. 3 VICE-CHAIR RAMOS: -- from the others 4 to be able to pass that. 5 COMM. TOLLIVER: Yeah, and mine is 6 just a perceived conflict. I don't know any -- I 7 don't know any of the people that were in that 8 case, but --9 VICE-CHAIR RAMOS: Right. 10 COMM. SILBERBERG: Same, yeah. 11 VICE-CHAIR RAMOS: Lindy, you got 12 Are you comfortable with that? that? 13 THE REPORTER: Yes. 14 VICE-CHAIR RAMOS: All right. 15 Thank you, Comm. Tolliver. 16 Any other public comments? 17 (No response.) 18 VICE-CHAIR RAMOS: Okay. And let me 19 see what the official time is. It's 1:30, and 20 we'll adjourn the meeting. 21 Thereupon, the proceedings of 22 July 21, 2023 were concluded at 1:30 o'clock p.m. 23
