
FINDINGS OF FACT, CONCLUSIONS OF LAW, AND ORDER

**PROPOSED FINDINGS OF FACT, CONCLUSIONS OF LAW,
AND ORDER**

On June 25, 2012, Complainants, Larry Fullington and Joseph R. Marcum (collectively "Complainants"), filed Complainants' Motion To Dismiss, a Motion to which Respondent, Claudeen Crump("Crump"), has not responded.

Having carefully considered the foregoing and being duly advised in the premises, the undersigned Administrative Law Judge for the Indiana Civil Rights Commission ("ICRC") proposes that the ICRC enter the following findings of fact, conclusions of law, and order.

FINDINGS OF FACT

1. These proceedings began when Complainants filed complaints with the ICRC alleging that they had been evicted from residential real estate by Crump because of race and/or disability.

2. Crump denied that Complainants were unlawfully evicted.
3. The Motion is expressly motivated by settlement.
4. There is no evidence of fraud, coercion, duress, or any other reason not to approve of the requested dismissal.
5. Any Conclusion Of Law that should have been deemed a Finding Of Fact is hereby adopted as such.


CONCLUSIONS OF LAW

1. The ICRC has jurisdiction over the subject matter and the parties.
2. Settlement is a favored resolution and should be encouraged.
3. Administrative review of this proposed decision may be obtained by the filing of a writing identifying with reasonable particularity each basis of each objection within 15 days after service of this proposed decision. IC 4-21.5-3-29(d).
4. Any Finding Of Fact that should have been deemed a Conclusion Of Law is hereby adopted as such.

ORDER

1. Complainants' Motion To Dismiss is **GRANTED**.
2. The Final Pre-Hearing Conference that had been scheduled for July 16, 2012 and the Hearing that had been scheduled for August 8, 2012 are **CANCELLED**.
3. Complainants' complaints are **DISMISSED**, with prejudice.




