

ABOUT GLENDA HATCHETT

Glenda Hatchett formerly presided over the syndicated show, *Judge Hatchett*, and is the founder of Parent Power Now, the premiere online

parenting network. The best-selling author of *Say What You Mean, Mean What You Say*, her forthcoming book is *Dare to Take Charge*.

After graduating from Emory University School of Law and completing a coveted clerkship in the US Federal Courts, Hatchett accepted a position at Delta Air Lines and became the company's highest-ranking African American woman. Hatchett's outstanding contributions in the business world were recognized by *Ebony* magazine, which named her one of the "100 Best and Brightest Women in Corporate America."

Hatchett left Delta Air Lines to accept an appointment as Chief Presiding Judge of the Fulton County, Georgia Juvenile Court. Upon accepting the position, she became Georgia's first African American Chief Presiding Judge of a state court and the department head of one of the largest juvenile court systems in the country.

Hatchett is a graduate of Mt. Holyoke College and has been recognized as a distinguished alumni and awarded an honorary degree by the college. Her law alma mater awarded her the Emory Medal, the highest award given to alumni by the university.

Hatchett has previously served on the Board of Directors of Gap, Inc., the Hospital Corporation of America (HCA), and The Service Master Company. Presently, she is on the Board of Advisors for the Atlanta Falcons Football Organization and Play Pumps International. She is also a member on the Boys & Girls Clubs of America National Board of Governors.
