Our office has received your NPDES Notice of Intent (NOI) submittal, dated November 1, 2023, requesting modification of your NPDES general permit coverage for the above-referenced facility. We are pleased to inform you that the submittal is sufficient to comply with the NOI requirements for 327 IAC 15-7 and that general permit coverage for this mine will be modified as follows:

- The mine drainage status of Outfall 037 is being reclassified from acid to alkaline,
- The mine drainage status of Outfall 041 is being reclassified from acid to reclamation/post-mining,
- Outfall 138 is being removed from permit coverage. The majority of the area has already received Phase II and Phase III bond release.

The NOI confirms that these changes have been discussed with the DNR inspector and no objections have been raised. My staff has reviewed the DNR site inspection report for November of 2023 which confirms this information.

We have reviewed your request and have determined that the activities associated with it will not violate the antidegradation rules as set forth in 327 IAC 2-1.3. Our office has further determined that the request will not affect this facility's eligibility for coverage under the general permit rules outlined in 327 IAC 15-1 through 15-4 and 327 IAC 15-7, Facilities Engaged in Mining of Coal, Coal Processing, and Reclamation Activities. Therefore, your petition to obtain permit coverage as is described in your NOI has been approved in accordance with Indiana rules promulgated under 327 IAC15-7 and 327 IAC 2-1.3.

The NPDES general permit identification number assigned to this facility is referenced above. Coverage for the facility will include all outfalls listed on the first table of Attachment 1 to this correspondence.

Since your permit coverage includes an outfall/basin with a Mine Drainage Status of "Reclamation" (Post-Mining), which is subject to quarterly monitoring and reporting requirements, it is necessary to set the effective date of permit coverage on the first day of a calendar quarter. Therefore, this **modified coverage is deemed effective on January 1, 2024.** This coverage will remain in effect until it expires on March 31, 2027. You are required to follow all terms and conditions of 327 IAC 15-7. In order to receive authorization to discharge beyond the date of expiration, you shall submit a renewal NOI to IDEM no later than ninety (90) days prior to the expiration date.

All NPDES permit holders are required to submit their monitoring data to IDEM using NetDMR. IDEM is required to serve notice of its decision to modify your facility's coverage under the general permit in accordance with the requirements of 327 IAC 5-3-14. It should also be noted that any appeal must be filed under procedures outlined in IC 13-15-6, IC 4-21.5, and the enclosed Public Notice. The appeal must be initiated by filing a petition for administrative review with the Office of Environmental Adjudication (OEA) within fifteen (15) days of the emailing of an electronic copy of this letter or within eighteen (18) days of the mailing of this letter. The Office of Water Quality approves the following NPDES GENERAL PERMIT action:

#### **MODIFICATION of COVERAGE under 327 IAC 15-7**

PEABODY MIDWEST MINING SOMERVILLE CENTRAL MINE, General NPDES Permit Coverage No. ING040190. The mine location is at 6280 S CR 1025 E, Oakland City, IN (GIBSON COUNTY). The permittee requested modification of current coverage under 327 IAC 15-7, the NPDES general permit-by-rule for Facilities Engaged of the Mining of Coal, Coal Processing, and Reclamation Activities. (This facility also operates under IDNR Permit No. S-322). The purpose of this modification is to reclassify the mine drainage status for two (2) outfalls, one from acid to alkaline and one from acid to reclamation/post-mining. Also Outfall 138 is being removed from coverage due to Phase II and Phase III bond release. As of this modification, this facility has four (4) remaining active outfalls, three of which discharge to Donohue Creek, and one (1) which discharges to an unnamed tributary of Smith Fork. #### **Notice of Right to Administrative Review**

If you wish to challenge this permit, you must file a Petition for Administrative Review with the Office of Environmental Adjudication (OEA) and serve a copy of the petition upon IDEM. The requirements for filing a Petition for Administrative Review are found in IC 4-21.5-3-7, IC 13-15-6-1 and 315 IAC 1-3-2. A summary of the requirements of these laws is provided below.

A Petition for Administrative Review must be filed with the Office of Environmental Adjudication (OEA) within fifteen (15) days of the issuance of this notice (eighteen (18) days if you received this notice by U.S. Mail), and a copy must be served upon IDEM. Addresses are:

The petition must contain the following information:

1. The name, address and telephone number of each petitioner.

- 2. A description of each petitioner's interest in the permit.
- 3. A statement of facts demonstrating that each petitioner is:
  - a. a person to whom the order is directed;
  - b. aggrieved or adversely affected by the permit; or
  - c. entitled to administrative review under any law.
- 4. The reasons for the request for administrative review.
- 5. The particular legal issues proposed for review.
- 6. The alleged environmental concerns or technical deficiencies of the permit.
- 7. The permit terms and conditions that the petitioner believes would be appropriate and would comply with the law.
- 8. The identity of any persons represented by the petitioner.
- 9. The identity of the person against whom administrative review is sought.
- 10. A copy of the permit that is the basis of the petition.
- 11. A statement identifying petitioner's attorney or other representative, if any.

Failure to meet the requirements of the law with respect to a Petition for Administrative Review may result in a waiver of your right to seek administrative review of the permit. Examples are:

- 1. Failure to file a Petition by the applicable deadline;
- 2. Failure to serve a copy of the Petition upon IDEM when it is filed; or
- 3. Failure to include the information required by law.

If you seek to have a permit stayed during the administrative review, you may need to file a Petition for a Stay of Effectiveness. The specific requirements for such a Petition can be found in 315 IAC 1-3-2 and 315 IAC 1-3-2.1.

Pursuant to IC 4-21.5-3-17, OEA will provide all parties with notice of any pre-hearing conferences, preliminary hearings, hearings, stays, or orders disposing of the review of this action. If you are entitled to notice under IC 4-21.5-3-5(b) and would like to obtain notices of any pre-hearing conferences, preliminary hearings, hearings, stays, or orders disposing of the review of this action without intervening in the proceeding you must submit a written request to OEA at the address above.

On behalf of Peabody Midwest Mining, LLC, I am submitting the attached modification request to the Somerville Central Mine NPDES Permit 040190. The modification requests are summarized in the following table:

Outfall	Requested Change
037	Reclassify from acid / ferruginous to alkaline mine drainage. The preparation plant and coal storage piles that were within this watershed have been removed and reclaimed. The area was topsoiled and seeded in 2023.
041	Reclassify from acid to reclamation drainage. The preparation plant and coal storage piles that were within this watershed have been removed and reclaimed. The area was topsoiled and seeded in 2023 and the remainder of this large watershed area has received Phase II and Phase III bond release.
138	Terminate this outfall from the NPDES permit. The watershed is densely vegetated, stable, and the majority of the area has received Phase II and Phase III bond release.

#### IX. PROOF OF PUBLICATION

This publication must be in the newspaper for a minimum of one day and must include the following language: (your facility name, address, address of the location of the discharging facility, and the streams receiving the discharge(s)) "is submitting a Notice of Intent letter to notify the Indiana Department of Environmental Management of our intent to comply with the requirement under 327 IAC 15-7 to discharge wastewater associated with the mining of coal, coal processing and /or reclamation activities. Any person aggrieved by this action may appeal in writing to the Environmental Law Judge of the Office of Environmental Adjudication for an adjudicatory hearing on the question of whether this facility should operate under this NPDES general permit rule. An appeal must be postmarked no later than fifteen (15) days from the date of this public notice. Such a written request for an adjudicatory hearing must:

- (A) state the name and address of the person making the request;
- (B) identify the interest of the person making the request;
- (C) identify any persons represented by the person making the request;
- (D) state with particularity the reasons for the request;
- (E) state with particularity the issues proposed for consideration at the hearing; and
- (F) state with particularity the reasons why the NPDES general permit rule should not be available to the discharger identified in this notice.
