### **Hoosier Riverwatch Visits Indiana Master Naturalist**

The Indiana Master Naturalist program brings together natural resource specialists with adult learners to foster an understanding of Indiana's plants, water, soil and wildlife and promotes natural resource volunteer service within the State of Indiana. Hundreds of Hoosiers participate in classes held statewide. Hoosier Riverwatch Coordinator Dylan Allison had the opportunity to speak to two IMN classes this spring.





The first class was held at Southeastway Park, managed by Indy Parks New Palestine. Dylan discussed the watersheds, water quality, and the Hoosier Riverwatch curriculum. As a special treat, IDEM fish biologists Kayla Werbianskyj and Cameron Yeakle conducted an electrofishing survey for the class.

# **Riverwatch Goes to School**

Hoosier Riverwatch Coordinator Dylan Allison was invited to participate in an outdoor education day for the sixth-grade class at Riverside Intermediate School in Fishers. The two-day event was an opportunity for students to learn about water quality and other environmental topics, rotating through stations throughout their school day. High waters kept the students from entering the neighboring White River. Instead, students used conducted D-nets and balloons to simulate macroinvertebrate collection.





Students ran a relay race during which they collected as many balloons for their team as possible. After the balloons were collected, leaders revealed that the a balloon's color determined the point value. This closely resembles the scoring system for Riverwatch's macroinvertebrate sampling; creatures with low pollution tolerance are scored more highly because they are associated with cleaner





waters. The students were energetic and engaged and left with a better understanding of macroinvertebrate sampling.

## Keep Indianapolis Beautiful Urban Naturalists Get Their Feet Wet

Hoosier Riverwatch Coordinator Dylan Allison connected with <u>Keep Indianapolis Beautiful</u> (KIB) urban naturalists during a hands-on "creek stomp". KIB's Urban Naturalist program employs young adults in environmental restoration projects throughout Indianapolis.





A team of college-aged stewards learned Hoosier Riverwatch sampling techniques at Fort Harrison State Park in Indianapolis. Additionally, discussions were held regarding careers with IDEM and within the environmental field.

KIB's mission is "to engage diverse communities to create vibrant public places, helping people and nature thrive." Each year, KIB supports nearly 20,000 volunteers who contribute to more than 800 community projects.
