After hearing about the details of the proposed Regional Haze State Implementation Plan for Indiana, I can say with all honesty that I am truly and deeply disappointed with our policy makers- specifically The Indiana Department of Environmental Management. As an eighteen-year-old college student, I recognize that I still have a lot more to learn about the environment and current policies in place. However, even I recognize the destructive consequences our state would undergo if this plan were set into action.

In my county alone, we have four power plants with Q/d values up to 10.7, with half of the plants having values over 10. Dear IDEM RHR SIP Architects,

As a decades long Indianapolis resident who now has spent more of her life living in the city than in the country, I was angered and disheartened at learning of this most recent version of the Clean Air Act RHR SIP for the state of Indiana. Suffice it to say that I spend a great deal of time hiking our state's most out of reach woodlands, prairies, and waterways, as well as northern Indiana and Kentucky. And though it is disturbing to me that visibility at national park monuments is reduced by haze, it is more troubling that Americans can't drive hundreds of miles away from source pollution to breathe clean air, regardless of whether they visit a national park or their local nature preserve.

We know the primary sources of this pollution are electric generating power plants fueled by fossil fuels like coal and gas. And we know that these pollutants contribute to as many premature deaths each year as the number of annual car crash fatalities. And yet, this SIP for regional haze regulation isn't calling for the immediate closure and just transition of outdated coal and gas power plants. Why not?

IDEM is missing a prime opportunity to fulfill, according to the IDEM website, one of it's own obligations, "to protect the quality of Indiana's air".

By omitting (from the SIP) mandated reductions, shut downs of coal and gas fired power plants in our state, more than 40,000 tons of nitrogen oxide and 50,000 tons of sulfur dioxide will continue to be released into the air without further controls over the next decade. And that works against IDEM's own stated goals.

IDEM website also says it's responsibilities, "couldn't be more important because air quality, or the lack of it, impacts the health of every person in our state every minute of every day." So they themselves know and publicly acknowledge that protecting air quality is vital as public health is affected "every minute of every day" by it.

Has the haze in the air muddled the authors' vision, so they can't see that this SIP avoids addressing the very problems it's designed to solve? One is tempted to think this strategy is intentional and that IDEM prefers to protect the status quo that profits utility shareholders and holds it in higher regard than public health.

To show Indiana Hoosiers and park visitors across the country IDEM puts its money where its mouth is, it must replace this current SIP with one that swiftly and without further delay forces reductions, and retires fossil fuel powered electric generating units in order to honor its own mandate to create a liveable, breathable habitat we don't have to drive a hundred miles away for. ### Comments on the Draft Indiana Regional Haze State Implementation Plan for the Second Implementation Period

I am going to first compare two lists, the list of twenty Indiana sources of haze in Table 7-1 of the Indiana Regional Haze document and the list of 22 Super polluters in the report published about four years ago by the Center For Public Integrity and the Weather Channel, (which received considerable media attention when released both in Evansville and Indiana, and nationally). In the latter study the top 100 polluters for carbon emissions and the top 100 for toxic emissions were listed, and the 22 superpolluters were identified as being on both lists.

Evansville was the focus of the Superpolluters report because four of the 22 superpolluters essentially surrounded Evansville. Those same four facilities also show up on the Table 7-1 Indiana haze list, not surprising since both, while having different objectives, local health effects vs. visibility in national parks, are based fundamentally on the same pollutants, SO<sub>2</sub> and NO<sub>x</sub>. Three of them are electric utilities, the other is the Alcoa Aluminum plant in Newburgh. I will discuss here primarily Alcoa, for a couple of reasons. First there is a degree of transparency to the public in the planning process with electric utilities through the Integrated Resource Plan process and the IURC review and approval process. As well, there is some progress on emission reductions with the public utilities, at Rockport, Petersburg and Gibson County, no doubt in part due to the transparency.

In contrast the situation at Alcoa is opaque to the public, with no information or involvement by the public in the planning process. As well, from the Regional Haze document, there appears to be no plans for emissions reductions at Alcoa, even though as shown in Table 7-1 it is by far the largest contributor to haze of all the industrial sources (ie "non EGU" sources) in Indiana.

The documents indicates that currently the primary method for controlling SO<sub>2</sub> emissions at Alcoa is use of low sulfur coke in its process. Clearly that is not doing the job. As well, NO<sub>x</sub> emissions are not even being measured.

The document discusses at length the possibility of installing scrubbers for SO<sub>2</sub> removal ("FGD system"). I strongly urge that Alcoa be required to proceed with that. Cost, timing ( up to 5 years) , energy consumption and by product disposal are discussed. Five year timing would not seem to be a problem since the plant could continue operation far into the future (to quote "the remaining life... cannot be predicted at this time") and the other considerations, including cost, are just typical of how all scrubbers operate, and obviously they are just accepted aspects of this type of technology, no reason Alcoa would not be able to manage them.

My name is Jean Webb, resident of Evansville, IN. Thank you for listening to my comments and requests regarding the IDEM Regional Haze State Implementation Plan. I have a treasured black and white photo taken when I was 5 years old at Mammoth Cave with my siblings and mother, and I have a nice color snapshot of my children when they were young at Mammoth Cave. I look forward to taking my granddaughter to Mammoth Cave soon.

I applaud the success of the Regional Haze program has already achieved in cleaning our air as graphically represented in Figure 5-1 of your report

However, also evident in Figure 5-1 is that Mammoth Cave is still located in the zone representing the dirtiest air in the nation. And, where I live, and where my granddaughter's developing lungs live, is also located in that same dirtiest zone in the nation. I ask you to take action to help us improve to the same degree as has been realized by both North and South Carolina.

My focus is on the three major haze contributors located near me in Warrick County, because I see them at least weekly on my walks on the Newburgh riverfront. I had a really difficult time following the report in regards to these plants, but these comments are based on my best attempt to understand the plan.

1) The report indicates that you were mistaken about Warrick 4 continuing operations beyond 2023, and an update will be made to the report (p75). To not have that data from Warrick 4 included until a 2025 report is NOT ACCEPTABLE. I don't know that the graphs currently in the report are accurate at all without Warrick 4. It seems premature to rely on retirements only to meet clean air goals, as seems to be your plan, instead of new pollution controls until the Warrick 4 data is included in the analysis. I am particularly concerned that although SOx has decreased over time from Warrick 4, NOx has not. NOx is a precursor to ozone, and is incredibly damaging, especially as climate change causes higher humidity on most days. I trust that rising humidity is factored into your studies. Please reserve your plan of action until the Warrick 4 data is included. The omission of Warrick 4 modeling beyond 2023 is not to be accepted as a minor "oops". It needs to be included in the 2021 plan.

2) It also doesn't appear that the Warrick Alcoa Power Plant has had any pollution controls installed since before 2007 (Table 8-3). So then I looked back to the 2016 report and found Table 2.2 - ALCOA BART analysis was performed. Your 2016 report includes the statement "On January 7th, 2016 Alcoa announced that it will permanently close its 269,000 metric ton Warrick Operations smelter by the end of the first quarter 2016". I'm not able to connect the dots. Did Alcoa escape controls by this closure announcement for a closure which turned out to be only temporary? Their NOx emissions are just as high now as when the program began at over 3,000 tons per year. Why? Did the false closure announcement allow them to escape enforcement?

3) I find it very dangerous to rely on non-binding coal plant retirement announcements and forecasts as an excuse to forgo actual action to reduce pollutants. Just look at the oversight mistakes that have already happened in the false smelter closure announcement and the "mistaken" Warrick 4 2023 retirement. I ask that IDEM do complete studies and enforce pollution reduction requirements unless a binding commitment for a retirement is made. The Integrated Resource Plans are not binding. I fear that with the skyrocketing cost of natural gas, some of the coal retirements may get delayed. These plants need to know the pollution controls they will need to implement should they attempt to delay announced retirements. If they change their minds it can't be a means of enjoying extra time to pollute like it appears Alcoa is doing.

In 2019 Southern Indiana lost an environmental hero, Bill Musgrave. While I speak today to ask that you do more to effectively implement the Regional Haze SIP, I can't help but think of the times he came to you and asked you for protections against Alcoa toxic by-products. Most recently in regards to Liberty Mine. Alcoa won't lessen their toxic emissions unless they are forced to do so. Don't slack off on Alcoa oversight.

Please do all that is within the power of the Regional Haze SIP to protect Mammoth Cave, me, my family, and my community from Alcoa haze-generating pollution.
