The Office of Medicaid Policy and Planning (OMPP) of the Indiana Family and Social Services Administration (FSSA) is planning a Request for Services (RFS) to provide risk-based managed care services to Medicaid beneficiaries enrolled in the Hoosier Healthwise and Healthy Indiana Plan (HIP) programs.

Hoosier Healthwise and HIP are Medicaid programs that help 680,000 Hoosiers. Together, these programs aim to provide comprehensive health care coverage for uninsured Hoosiers. Both programs seek not only to provide health coverage to an uninsured population, but to improve health, promote prevention and encourage healthy lifestyles. The purpose of the RFS is to integrate the two programs to the greatest extent possible, thus creating a "family health plan" that results in a seamless experience for Hoosier families.
