Dear Judge Loyd:

An inspection of the juvenile detention standards as required by 210 IAC 6 was conducted at the Johnson County Juvenile Detention Center on February 12, 2013. The inspection was conducted by Director Vanessa Krause, Shannon Bowling, and Jan Adams.

The Johnson County Juvenile Detention Center is located at 1121 Hospital Road in Franklin, Indiana. The rated bed capacity of the center is forty-eight, with forty beds slated for male residents, and eight beds for female residents. The Director of the facility is Jim Higdon, and the Assistant Director is Kristi Bruther.

This inspection constitutes the seventeenth-annual inspection of the Johnson County Juvenile Detention Center. Compliance with all mandatory standards and at least 90% of the recommended standards is required to attain "Full Compliance". The inspection included a review of all standards, a tour of the facility, and interviews with detention staff and residents. Juveniles offered no instances of mistreatment and were complimentary towards the center, and its staff. Staff were well versed in policy and procedure, and offered support for administration.

Summary of Tour:

- The facility was clean, well maintained, and free of odor.
