**FINDINGS OF FACT AND SUSPENSION ORDER**

WHEREAS, on January 26, 2012, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Kerry L. Laughman (“Respondent”) a certified letter requesting a list of appointments and a written response to a complaint received by the Department. The letter was mailed to 17123 Killarney, Granger IN 46530, Respondent’s address of record with the Department.

WHEREAS, this letter was returned as undeliverable by the US Postal Service.

WHEREAS, on February 7, 2012, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Kerry L. Laughman (“Respondent”) a certified letter requesting a list of appointments and a written response to a complaint received by the Department. The letter was mailed to 5915 Mission Trail, Apt. 13, Granger IN 46530, Respondent’s previous address of record with the Department.

WHEREAS, this letter was returned as undeliverable by the US Postal Service.

WHEREAS, on February 17, 2012, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Kerry L. Laughman (“Respondent”) a certified letter requesting a list of appointments and a written response to a complaint received by the Department. The letter was mailed to 3569 N. Karnwood Drive, Port Clinton, OH 43452. The

Department had received information that Mr. Laughman was co-habiting at that address with Dorinda K. Bowser, also a licensed producer.

WHEREAS, on February 21, 2012, certified mail article #7005 3110 0002 4444 1899, was signed for by Dorinda Bowser, indicating receipt of the Commissioner's request.

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days as requested by the Commissioner.


WHEREAS, Respondent's failure to provide said list constitutes a violation of IC 27-1-15.6-12(g).

WHEREAS, the Commissioner has the authority to issue an order suspending Respondent's license without a hearing pending receipt of said list of appointments pursuant to IC 27-1-15.6-12(g).

WHEREAS, the Commissioner shall set this matter for hearing upon request of Respondent pursuant to IC 4-21.5-4-4.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 492937 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments and response requested by the Commissioner.
