FINAL ORDER AND APPROVAL



AGREED ENTRY

This Agreed Entry is entered into by the Enforcement Division of the Indiana Department of Insurance (the "Department"), by and through counsel, Michael F. Mullen, and Respondent Ruby M. Toosevich ("Respondent") to resolve all matters under Cause Number 10849-AG12-0417-026. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance (the "Commissioner").

WHEREAS, on February 7, 2011, Respondent was issued non-resident producer license number 740595 ("Respondent's Indiana license"); and,

WHEREAS, on April 18, 2012, the Department filed a Statement of Charges in the above-captioned matter; and,

WHEREAS, on September 28, 2012, the Commissioner issued an Order suspending Respondent's Indiana license; and,

WHEREAS, on July 26, 2012—two months prior to the Commissioner’s Order—the Illinois Department of Insurance permanently revoked Respondent’s resident license; and,

WHEREAS, the Department and Respondent (collectively, the “Parties”) desire to resolve their differences and settle all issues without the necessity a hearing.

IT IS, THEREFORE, NOW AGREED by and between the Parties as follows:

1. The Commissioner has jurisdiction over the subject matter and Respondent in this administrative action.
2. This Agreed Entry is executed voluntarily by the Parties.
3. Respondent voluntarily and freely waives her right to a public hearing on this matter.
4. Respondent’s Indiana license shall be permanently revoked, effective the date the Commissioner adopts this Agreed Entry via Final Order.
5. The Department agrees to accept Respondent’s compliance with the terms of this Agreed Entry as full resolution of this matter.
6. Respondent has carefully read and examined this Agreed Entry and fully understands its terms.
7. Respondent has entered into this Agreed Entry freely on her own volition and has not been subject to duress, threat, undue influence, or any form of coercion.
8. Respondent is aware that failure to comply with any term of this Agreed Entry may result in this matter being set for hearing.
9. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that the presentation to and consideration of this Agreed Entry by the Commissioner
