FINAL ORDER


The Indiana Department of Insurance (“Department”) and Douglas Harrison, an Indiana resident holding insurance producer’s license number 2132770 and the qualifying active officer of Insurance Specialists of Indiana, a resident insurance agency holding license number 37340 (collectively, “Respondents”), signed an Agreed Entry which purports to resolve all issues regarding the above cause number, and which has been submitted to the Commissioner of Insurance (the “Commissioner”) for approval.

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS, THEREFORE, ORDERED, by the Commissioner of Insurance:

1. Respondents' actions, as detailed in the Agreed Entry, are in violation of Indiana Code § 27-1-15.6-12(b)(4), § 27-1-15.6-12(b)(8) and §27-1-15.6-12(g).
2. Respondents shall pay an administrative fine in the amount of \$1,000.00 within thirty (30) days.

AGREED ENTRY

This Agreed Entry is executed by Nikolas P. Mann, Attorney for and on behalf of the State of Indiana, Indiana Department of Insurance ("Department"), and Douglas Harrison and Insurance Specialists of Indiana (collectively "Respondents"), to resolve all issues in the above cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner, Indiana Department of Insurance.

WHEREAS, Respondent Harrison is licensed as an individual resident insurance producer in the State of Indiana, holding license number 2132770 since April 13, 1985; and,

WHEREAS, Respondent Harrison is the qualifying active officer for Respondent Insurance Specialists of Indiana, Inc., a licensed resident producer agency holding license number 37340 since October 25, 2005; and,

WHEREAS, on February 5, 2012, the Department received a complaint from an Indiana resident stating that she had paid the sum of \$652.00 to Respondents on or around February 23,

2011 for premiums on a homeowners insurance policy for her property, however, when she contacted the insurer supposedly underwriting her coverage, she learned that no insurance policy existed; and,

WHEREAS, a copy of the complaint and a request to submit a list of company appointments was sent to Respondents by certified mail number 7005 3110 0002 4443 5164; and,

WHEREAS, Respondent failed to respond to the Department's request within ten (10) days as required by Indiana Code §27-1-15.6-12(g); and,

WHEREAS, in conversations with the Department, Respondents have stated that due to an oversight, a policy was never secured for the complainant; and,

WHEREAS, since the filing of the complaint, Respondents have made full restitution to the complainant; and,

WHEREAS, Respondent's conduct, as alleged herein, constitutes a violation of Indiana Code §27-1-15.6-12(b)(4), §27-1-15.6-12(b)(8) and §27-1-15.6-12(g); and,

WHEREAS, the Department and Respondents desire to resolve their differences and settle the issues without the necessity of a hearing;

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and Respondents in this administrative action.
2. This Agreed Entry is executed voluntarily by the parties.
3. Respondents voluntarily and freely waive the right to a public hearing.
4. Respondents voluntarily and freely waive the right to judicial review of this matter.


5. Respondents shall pay an administrative fine in the amount of \$1,000.00 within thirty (30) days of the Final Order adopting this Agreed Entry.
6. Respondents' licenses will be placed on probation for a period of one (1) year.
7. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
8. Respondents have carefully read this agreement and fully understand and accept its terms.
