FINAL ORDER

WHEREAS, Applicant's behavior, as alleged herein, violates Indiana Code § 27-1-15.6-12 (b)(8); and,

WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without a hearing;


IT IS THEREFORE NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Applicant in this administrative action.
2. This Agreed Entry is executed voluntarily by the parties.
3. Applicant voluntarily and freely waives the right to a public hearing.
4. Applicant voluntarily and freely waives the right to judicial review of this matter.
5. Applicant's application for a producer's license shall be granted and immediately placed on probationary status for a period of two (2) years.
6. Applicant has carefully read this agreement and fully understands and accepts its terms.
7. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
