**FINAL ORDER**

The Indiana Department of Insurance (“Department”) and Judy J. Subris (“Subris”), a licensed resident insurance producer, signed an Agreed Entry which purports to resolve all issues involved in the action by the Department regarding Subris’ license, and which has been submitted to the Commissioner of Insurance (the “Commissioner”) for approval.


The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry, attached as Exhibit A, as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner as follows:

1. Subris’ producer license will be placed on probation for a period of one (1) year.
2. Subris will pay an Administrative Fine of Seven Hundred and Fifty and 00/100 Dollars (\$750.00). Payment will be made within thirty (30) days of this Final Order.

3. The Department agrees to accept Subris' compliance with the terms of this Final Order as full resolution of the issues regarding Subris' Resident Producer License.

**AGREED ENTRY**

This Agreed Entry is executed by and between the Indiana Department of Insurance (“Department”), by counsel, and Respondent, Judy J. Subris (“Respondent”). This Agreed Entry is subject to the review and approval of the Commissioner of the Department.

WHEREAS, Respondent is a resident licensed insurance producer in the State of Indiana, holding license number 2500720.

WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without a hearing or the necessity of filing a statement of charges.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter of and the parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the parties.
3. Respondent voluntarily and freely waives her right to a public hearing.

4. Respondent voluntarily and freely waives her right to petition for judicial review of this Agreed Entry and the Commissioner's Final Order.
5. Respondent used fraudulent, coercive, or dishonest practices, or demonstrated incompetence, untrustworthiness, or financial irresponsibility in the conduct of business in Indiana in violation of Ind. Code § 27-1-15.6-12(b)(8).
6. Respondent's producer license will be placed on probation for a period of one (1) year immediately upon the signing of the Final Order by the Commissioner.
7. Respondent shall pay an Administrative fine of Seven Hundred and Fifty 00/100 dollars (\$750.00), made payable to the State of Indiana within thirty (30) days of the Commissioner signing the Final Order.
8. The Department agrees to accept Respondent's compliance with the terms of this Agreed Entry as full resolution of this matter.
9. Respondent is aware that her failure to comply with any term of this agreement will result in the matter being set for hearing.
10. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
11. Respondent has carefully read and examined this agreement and fully understands and accepts its terms.
