

3. Upon the Commissioner's signature of the Final Order, and receipt of the administrative fine payment, Huebner's Non-Resident Independent Adjuster License Application will be processed in the normal manner.
4. The Department agrees to accept Respondent's compliance with the terms of this agreement as full resolution of the issues regarding Respondent's Non-Resident Independent Adjuster License application.

**AGREED ENTRY**

This Agreed Entry is executed by and between the Indiana Department of Insurance ("Department"), by counsel, and Charles R. Huebner ("Huebner"), an applicant for a resident insurance producer license. This Agreed Entry is subject to the review and approval of the Commissioner of the Department.

WHEREAS, Huebner is a resident of Texas;

WHEREAS, Huebner submitted an application for a Non-Resident Independent Adjuster License on July 3, 2012;

WHEREAS, Huebner failed to disclose two (2) misdemeanor convictions on his application;

WHEREAS, the Department and Huebner desire to settle the issues without a hearing;  
and

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter of and the parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the parties.
3. Huebner voluntarily and freely waives his right to a public hearing.
4. Huebner voluntarily and freely waives his right to petition for judicial review of this agreement and the Commissioner's Final Order.
5. Huebner failed to disclose two (2) misdemeanor convictions on his application for a non-resident independent adjuster license, in violation of Ind. Code § 27-1-28-18(b)(1).
6. Huebner will pay an Administrative Fine of Two Hundred Fifty and 00/100 Dollars (\$250.00). Payment will be made within thirty (30) days of the Commissioner's Final Order.
7. Upon the Commissioner's signature of the Final Order, and receipt of the administrative fine payment, Huebner's Independent Adjuster License Application will be processed in the normal manner.
8. The Department agrees to accept Huebner's compliance with the terms of this agreement as full resolution of the issues regarding Respondent's Independent Adjuster License application.
9. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

10. Huebner has carefully read and examined this agreement and fully understands its terms.
