FINAL ORDER

The Indiana Department of Insurance (“Department”) and Simone C. Swan-Logan (“Swan-Logan”), an applicant for an Indiana non-resident insurance producer license, signed an Agreed Entry which purports to resolve all issues involved in the action by the Department regarding Swan-Logan’s license application, and which has been submitted to the Commissioner of Insurance (the “Commissioner”) for approval.

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry, attached as Exhibit A, as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.


IT IS THEREFORE ORDERED by the Commissioner as follows:

1. Swan-Logan will pay an Administrative Fine of Five Hundred Dollars (\$500.00). This payment will be made in two (2) installments of Two Hundred and Fifty Dollars (\$250.00). The first payment will be paid within thirty (30) days of the

Commissioner's Final Order. The second payment will be paid within 60 days of the Commissioner's Final Order.

2. Upon the Commissioner's signature of the Final Order, the Department will process Swan-Logan's license application in the normal manner.
3. The Department agrees to accept Swan-Logan's compliance with the terms of this agreement as full resolution of the issues regarding Swan-Logan's producer license application.

AGREED ENTRY

This Agreed Entry is executed by and between the Indiana Department of Insurance ("Department"), by counsel, and Simone C. Swan-Logan ("Swan-Logan"), an applicant for an Indiana non-resident insurance producer license. This Agreed Entry is subject to the review and approval of the Commissioner of the Department.

WHEREAS, Swan-Logan is a resident of Georgia;

WHEREAS, on or about August 8, 2012, Swan-Logan submitted an application for an Indiana Non-Resident Insurance Producer License;

WHEREAS, Swan-Logan failed to disclose Administrative Actions by Georgia and Oklahoma on her license application, in accordance with Indiana Code;

WHEREAS, the Department and Swan-Logan desire to settle the issues without a hearing; and

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and Swan-Logan in this administrative action.
2. This Agreed Entry is executed voluntarily by and between the parties.
3. Swan-Logan voluntarily and freely waives her right to a public hearing on this matter.
4. Swan-Logan voluntarily and freely waives her right to petition for judicial review of this agreement and the Commissioner's Final Order.
5. Swan-Logan will pay an Administrative Fine of Five Hundred Dollars (\$500.00). This payment will be made in two (2) installments of Two Hundred and Fifty Dollars (\$250.00). The first payment will be paid within thirty (30) days of the Commissioner's Final Order. The second payment will be paid within 60 days of the Commissioner's Final Order.
6. Upon the Commissioner's signature of the Final Order, the Department will process Swan-Logan's license application in the normal manner.
7. The Department agrees to accept Swan-Logan's compliance with the terms of this agreement as full resolution of the issues regarding Swan-Logan's producer license application.
8. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

9. Swan-Logan has carefully read this agreement and fully understands and accepts its terms.
