FINAL ORDER

The Indiana Department of Insurance (“Department”) and Roger Joseph Hurry (“Hurry”), a licensed resident Indiana insurance producer, signed an Agreed Entry which purports to resolve all issues involved in the action by the Department regarding Respondent’s license, and which has been submitted to the Commissioner of Insurance (the “Commissioner”) for approval.

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Respondent shall pay a civil penalty in the amount of two hundred fifty dollars (\$250.00) payable within thirty (30) days from the date of this Final Order.

AGREED ENTRY

This Agreed Entry is executed by and between the Indiana Department of Insurance ("Department"), by counsel, and Roger Joseph Hurry ("Hurry"), an Indiana resident insurance producer. This Agreed Entry is subject to the review and approval of the Commissioner of the Department.

WHEREAS, Hurry is a resident of Indiana;

WHEREAS, Hurry is a licensed insurance producer, holding license number 2215500;

WHEREAS, on or about July 2, 2012, Hurry submitted a change of beneficiary form to the American National Insurance Company that contained a forged signature of the policy owner;

WHEREAS, Hurry admits he failed to obtain an original signature of the policy owner in violation of Ind. Code § 27-1-15.6-12(b)(8); and,

WHEREAS, the Department and Hurry desire to settle the issues without a hearing.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter of and the parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the parties.

3. Hurry voluntarily and freely waives his right to a public hearing.
4. Hurry voluntarily and freely waives his right to petition for judicial review of this agreement and the Commissioner's Final Order.
5. Hurry agrees to pay a civil penalty in the amount of two hundred fifty dollars (\$250.00), due within thirty (30) days from the date the Commissioner signs the Final Order in this matter.
6. The Department agrees to accept Hurry's compliance with the terms of this agreement as full resolution of the issue.
7. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
8. Hurry has carefully read and examined this agreement and fully understands its terms.
