
**FINDINGS OF FACT AND SUSPENSION ORDER**

The Indiana Department of Insurance, pursuant to, Indiana Code § 4-21.5-1 *et seq.* and Indiana Code § 27-1-15.6-12, hereby gives notice to Angelo Guitierrez, (“Respondent”) of the following Administrative Order:

- 1) Respondent is a licensed producer; license 725169, issued October 10, 2010.
- 2) Indiana Code 27-1-15.6-12(g) states that “A licensed producer shall... not more than ten (10) days after the producer receives a request in a registered or certified letter from the commissioner, furnish the commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request.”
- 3) On October 28, 2014 the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Angelo Gutierrez (“Respondent”) a certified letter requesting a list of appointments and

- 4) On October 28, 2014, certified mail article # 9214 8901 0661 5400 0042 8001 76 was delivered and signed by Sylvia Gutierrez.
- 5) Respondent has failed to provide a list of appointments within ten (10) days as requested by the Commissioner.
- 6) Indiana Code 27-1-15.6-12(h) states that "If a licensee fails to provide the report requested under subsection (g)... the commissioner may, in the commissioner's sole discretion, without a hearing, and in addition to any other sanction allowed by law, suspend any insurance license held by the licensee pending receipt of the appointment report.
- 7) Indiana Code § 27-1-15.6-12(d) indicates that the Respondent may, within sixty three (63) days of receiving this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.
- 8) IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 725169 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments and response requested by the Commissioner.
