

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Respondent shall pay an administrative fine of Five Hundred Dollars and no/100 (\$500.00) within thirty (30) days of today’s date.

2. Upon payment of said administrative fine, Respondent renewal shall be granted.

AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Michael F. Mullen, and Kathleen Metter (“Respondent”), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance.

WHEREAS, Respondent submitted an application for a Non-Resident Producer’s license on October 12, 2011; and

WHEREAS, on said application, Respondent failed to disclose a 2009 felony conviction of Driving While Intoxicated in the State of Texas; and

WHEREAS, after having obtained said license, Respondent failed to report an administrative action taken against her in Louisiana Department of Insurance in 2012; and

WHEREAS, Applicant’s conduct, as alleged herein, constitutes a violation of Indiana Code §27-1-15.6-12(b)(1) and §27-1-15.6-17(a); and

WHEREAS, on October 8, 2013 Respondent submitted an application to renew her license, which expires on October 31, 2013; and

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve these issues without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the Parties.
3. Respondent voluntarily and freely waives the right to a public hearing on this matter.
4. Respondent voluntarily and freely waives the right to judicial review of this agreement and the Commissioner's Final Order.
5. Respondent shall pay an administrative fine in the amount of Five Hundred Dollars and 00/100 (\$500.00) within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
6. Provided no other issues arise, once said administrative fine is paid, Respondent's license shall be renewed.
7. Respondent understands that this Agreed Entry and subsequent Final Order will result in a state action against her Indiana nonresident license, and Respondent may be required to report that action to other states where she holds or applies for professional licenses.
8. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall

not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.


9. Respondent has carefully read this agreement and fully understands and accepts its terms.


