

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Applicant shall pay an administrative fine of Two Hundred Fifty Dollars and no/100 (\$250.00) within thirty (30) days of today’s date.

2. Upon payment of said administrative fine, Applicant's license shall be granted.

AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Michael F. Mullen, and Applicant Deanna Gonzalez ("Applicant"), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance.

WHEREAS, on January 10, 2014, Applicant submitted an application for a Non-Resident Producer's license; and

WHEREAS, on said license application, Applicant failed to disclose a 2010 administrative action and subsequent license denial taken against her by the Florida Office of Insurance Regulation; and

WHEREAS, the Department alleges that Applicant's conduct constitutes a violation of Indiana Code §27-1-15.6-12(b)(1); and


WHEREAS, the Department and Applicant (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:


1. The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the Parties.
3. Applicant voluntarily and freely waives the right to a public hearing on this matter.
4. Applicant voluntarily and freely waives the right to judicial review of this agreement and the Commissioner's Final Order.
5. Applicant shall pay an administrative fine in the amount of Two Hundred Fifty Dollars and 00/100 (\$250.00) within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
6. Respondent acknowledges Ind. Code § 27-1-15.6-17(b) requires her to report to the Commissioner, not more than thirty (30) days after an initial pretrial hearing date, any criminal prosecution initiated in any jurisdiction.
7. Respondent also acknowledges Ind. Code § 27-1-15.6-17(a) requires her to report to the Commissioner, not more than thirty (30) days after the final disposition of the matter, any administrative action taken against the producer in another jurisdiction or by another governmental agency in Indiana.

8. Provided no other issues arise, once said administrative fine is paid, Applicant's application for licensure shall be granted.
9. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
10. Applicant has carefully read this agreement and fully understands and accepts its terms.


