PRELIMINARY ADMINISTRATIVE ORDER
AND NOTICE OF LICENSE RENEWAL DENIAL

The Indiana Department of Insurance, pursuant to the Indiana Administrative Act, Indiana Code §§4-21.5-1 et seq. and 27-10-3-8, hereby gives notice to Tamara S. Kuhn (“Applicant”) of the following Administrative Order:


1. Applicant filed an application for renewal of her bail agent license with the Commissioner of the Indiana Department of Insurance (“Commissioner”) on September 30, 2013. Following a review of materials submitted by Applicant in support of her application and further investigation by the Department, the Commissioner, being fully advised, now hereby notifies Applicant that she is not qualified for licensure under Indiana Code §§27-10-3-8(a)(3 and 8). Specifically, at the time Applicant submitted her license renewal application, she had outstanding Indiana state tax liabilities in the warrant stage as reported to the Department by the Indiana Department of Revenue. As of February 28, 2014, Applicant still had outstanding tax liabilities in the warrant stage. Under Indiana Code §27-10-3-8(a)(8), the Commissioner shall refuse to renew a bail agent license if the applicant has an outstanding state tax warrant. Additionally, on Applicant’s license renewal application, she stated that she did not have any outstanding state tax warrants. Under Indiana Code §27-10-3-8(a)(3), the Commissioner shall

refuse to renew a bail agent license if the Applicant has made a material misstatement or misrepresentation in obtaining the license.

2. Under Indiana Code §4-21.5-3-7, if you wish to file a petition for review of the Preliminary Administrative Order and Notice of License Denial, you must do so in writing within fifteen (15) days after you receive notice of this Order. Submit your petition to the attention of Investigator Mike Herndon.

IT IS THEREFORE ORDERED that the Applicant's request for renewal of her bail agent license is hereby DENIED pursuant to Indiana Code §§27-10-3-8(a)(3 and 8).
