**FINAL ORDER**

The Indiana Department of Insurance (“Department”), by its counsel, Joshua Harrison, and Spencer R Brummett (“Respondent”), a licensed title insurance agent, signed an Agreed Entry which purports to resolve all issues involved in the action by the Department and which has been submitted to the Commissioner of Insurance (the “Commissioner”) for approval.

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Respondent shall pay an administrative penalty in the amount of five hundred dollars (\$500.00) to the Department. This amount is due in full within thirty (30) days of this Final Order

**AGREED ENTRY**

This Agreed Entry is executed by Robert L. Hummel, attorney for the Title Division of the Indiana Department of Insurance (“Division”), and Spencer R. Brummett, (“Respondent”), a title insurance agent not licensed to do business in Indiana, to resolve all issues in the above captioned matter. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner, Indiana Department of Insurance (“Commissioner”).

WHEREAS, Respondent worked as a resident title insurance producer without a license in the State of Indiana; and

WHEREAS, Respondent negotiated the terms of title insurance documents during the time he was not licensed, and benefited financially from that activity; and

WHEREAS, the Division and Respondent desire to resolve their differences and settle the issues without a hearing;

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and Respondent in this civil action.
2. This Agreed Entry is executed voluntarily by the parties.
3. Respondent voluntarily and freely waives his right to a public hearing in this matter.
4. Respondent voluntarily and freely waives his right to judicial review of this matter.
5. Respondent agrees to pay a civil penalty in the amount of five hundred dollars (\$500.00) to the Department. The payment is due in full within thirty (30) days after the Commissioner signs the Final Order.
6. Respondent shall not engage in the sale, solicitation, or negotiation of title insurance while unlicensed.
7. Respondent shall obtain an Indiana title insurance producer license within (30) days after the Commissioner signs the Final Order.
8. The Department agrees to accept Respondent's compliance with this agreement as full resolution of this matter.
9. Respondent has carefully read this agreement and fully understands and accepts its terms.


10. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

11. Respondent is aware that failure to comply with any of the terms of this agreement will result in the matter being set for hearing and may result in an additional civil penalty.
