AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Joshua D. Harrison, and Lynn Hewitt (“Respondent”), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of the Department’s Commissioner, Stephen W. Robertson.

WHEREAS, Respondent is a licensed Resident Insurance Producer, holding license number 790683; and

WHEREAS, on or about May 28, 2014, Respondent was terminated from Bankers Life and Casualty Company (“BLCC”) due to allegations of material misrepresentation on applications and allegations of forgery on delivery receipts; and

WHEREAS, Respondent’s actions, as alleged herein, are in violation of Indiana Code § 27-1-15.6-12(b)(5) and § 27-1-15.6-12(b)(10); and

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.


IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Respondent for this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the Parties.
3. Respondent voluntarily and freely waives his right to a public hearing on this matter.
4. Respondent voluntarily and freely waives the right to judicial review of this agreement and the Commissioner's Final Order.
5. Respondent agrees to the Permanent Revocation of his Resident Insurance Producer's License.
6. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.


7. Respondent has carefully read and examined this agreement and fully understands and accepts its terms.

FINAL ORDER

Harrison, and Lynn Hewitt (“Respondent”), a licensed resident insurance producer, signed an Agreed Entry which purports to resolve all issues involved in the above-captioned cause number, and which has been submitted to the Commissioner of the Indiana Department of Insurance (the “Commissioner”) for approval.

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry, attached, as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.


IT IS THEREFORE ORDERED by the Commissioner as follows:

1. Respondent’s Indiana Resident Insurance Producer License, number 790683, is hereby permanently revoked for intentionally misrepresenting the terms of a

proposed insurance contract and for forging another's name to multiple documents related to an insurance transaction.

2. The Department agrees to accept this agreement as full resolution of this matter.
