
WHEREAS, Respondent is a resident of Indiana;

WHEREAS, Respondent is a licensed Indiana resident insurance producer, holding license number 612524;


WHEREAS, on October 3, 2014, the Department received a complaint from Sally Yokum ("Yokum"), an insurance producer under the direct supervision of the Respondent, alleging Respondent had rewritten insurance applications submitted by Yokum and forged another producer's name to the applications prior to submitting them to the underwriting company for issue;

5. Respondent's resident insurance producer license number 6124524 shall be permanently revoked, effective the date of the Commissioner's Final Order in this matter.
6. The Department agrees to accept Respondent's compliance with the terms of this agreement as full resolution of this matter.
7. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
8. Respondent has carefully read and examined this agreement and fully understands its terms.
9. Respondent has been represented by counsel, Kenneth M. Wilk of Rubino, Ruman, Crosmer & Polen, LLC, throughout this matter.


