**FINAL ORDER**

The Indiana Department of Insurance (“Department”), by counsel, Joshua D. Harrison, and American Ins Marketing Services (“Applicant”), an applicant for an Indiana Nonresident Producer Organization license, signed an Agreed Entry which purports to resolve all issues involved in the above-captioned cause number, and which has been submitted to the Commissioner of the Indiana Department of Insurance (the “Commissioner”) for approval.


The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry, attached, as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Applicant shall pay an administrative fine of Two Hundred Fifty Dollars and no/100 (\$250.00) within thirty (30) days of today’s date.

2. Upon payment of said administrative fine, Applicant shall be granted a Nonresident Producer Organization license.

**AGREED ENTRY**

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Joshua D. Harrison, and American Ins Marketing Services ("Applicant"), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance.

WHEREAS, on October, 7 2014, Applicant submitted an application for a Nonresident Producer Organization's license; and,

WHEREAS, on said license application, Applicant failed to disclose a 2011 administrative action by the Massachusetts Division of Insurance; and,

WHEREAS, the Department alleges that Applicant's conduct constitutes a violation of Indiana Code §27-1-15.6-12(b)(1); and,

WHEREAS, Ashley Dean Aaron, President of American Ins Marketing Services, is authorized to act on behalf of Applicant and obligate it to perform in accordance with this agreement; and,

WHEREAS, the Department and Applicant (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:


1. The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the Parties.
3. Applicant voluntarily and freely waives the right to a public hearing on this matter.
4. Applicant voluntarily and freely waives the right to judicial review of this agreement and the Commissioner's Final Order.
5. Applicant also acknowledges Ind. Code § 27-1-15.6-17(a) requires them to report to the Commissioner, not more than thirty (30) days after the final disposition of the matter, any administrative action taken against the producer organization in another jurisdiction or by another governmental agency in Indiana.
6. Applicant shall pay an administrative fine in the amount of Two Hundred Fifty Dollars and 00/100 (\$250.00) within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
7. Provided no other issues arise, once said administrative fine is paid, Applicant's application for licensure shall be granted.

8. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
9. Applicant has carefully read this agreement and fully understands and accepts its terms.
