FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, John Oliver (“Respondent”) is a nonresident insurance producer under license # 882969.

WHEREAS, Indiana Code 27-1-15.6-12(g) states that a licensed producer must furnish the commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding within ten (10) days of a request.

WHEREAS, on December 23, 2014, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a certified letter requesting a list of appointments.

WHEREAS, on January 30, 2015, certified mail article # 9214 8901 0661 5400 0046 3583 38 was returned by the United States Postal Service (“USPS”) marked as return to sender because it was unclaimed.

WHEREAS, on March 03, 2015, the Commissioner resent the request for a list of appointments to Respondent via email to the email addresses JOliver@geico.com and licensingmoat@geico.com, which are on record for Respondent.


WHEREAS, the March 03, 2015 email included a request for a "delivery receipt". A delivery receipt was received by the Department that same day, indicating that the email to Respondent was delivered successfully to both addresses.

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days as required under Indiana Code 27-1-15.6-12(g).

WHEREAS, Indiana Code 27-1-15.6-12(h) provides that the commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 882969 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
