ADMINISTRATIVE ORDER
NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance, pursuant to, Indiana Code § 4-21.5-1 *et seq.* and Indiana Code § 27-1-15.6-12, hereby gives notice to Alan Pickett, (“Respondent”) of the following Administrative Order:

1. Respondent, a resident of Indiana, is a licensed resident insurance producer under license number 528359.
2. Respondent has been licensed in the state of Indiana since March of 2007.
3. Respondent’s resident producer’s license expires on November 30, 2015.
4. On December 23, 2014, the Department received a letter from Transamerican Premier Life Insurance Company (“Transamerican”). The letter indicated that Respondent, an agent for Transamerican, had been terminated on June 20, 2013 for failure to remit premiums collected on behalf of the company


5. Indiana Code 27-1-15.6-12(b)(4) states, in part, that the Commissioner may refuse to renew an insurance producer's license for improperly withholding, misappropriating, or converting any monies or properties received in the course of doing insurance business.

6. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of the reason for the nonrenewal of his license. This Order serves as that notice.

7. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty three (63) days of receiving this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that **his license shall not be renewed.**
