FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Onpoint Underwriting, Inc. (“Respondent”) is a nonresident insurance producer under license # 548486 and Non-Resident Surplus Lines under license # 655163.

WHEREAS, Indiana Code 27-1-15.6-12(g) states that a licensed producer must furnish the commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding within ten (10) days of a request.

WHEREAS, on January 28, 2015, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a certified letter requesting a list of appointments to the mail address on record for Respondent.

WHEREAS, on February 10, 2015, the certified mail receipt for article # 9214 8901 0661 5400 0049 2530 29, was returned by the United States Postal Service (“USPS”) marked as not deliverable and unable to forward. This indicate that Respondent did not update its business address with the Department as required by statute.

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days as requested by the Commissioner.


WHEREAS, Respondent's failure to provide said list within ten (10) days constitutes a violation of Indiana Code 27-1-15.6-12(g).

WHEREAS, Indiana Code 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in his sole discretion, issue an order to suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days.

WHEREAS, pursuant to Indiana Code 4-21.5-4-4, the Commissioner shall set this matter for hearing on this Order upon a request by Respondent.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license numbers 548486 and 655163 are hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments and response requested by the Commissioner.
