FINAL ORDER AND APPROVAL

The Enforcement Division of the Indiana Department of Insurance (“Department”) by counsel, Joshua D. Harrison, and Joshua A. Baldwin, (“Respondent”), signed an Agreed Entry which purports to resolve all issues involved in the above-captioned cause number, and which has been submitted to the Commissioner of the Indiana Department of Insurance (the “Commissioner”) for approval.

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED, by the Commissioner of Insurance:

1. Respondent is to make a payment of a civil penalty in the amount of two hundred fifty dollars (\$250.00), for failure to report a criminal action to the Department within the time period required by Indiana Code, which shall be payable by cashier's check or money order to the Indiana Department of Insurance within ninety (90) days from the date of the Commissioner's Final Order.

AGREED ENTRY

This Agreed Entry is entered into by Joshua D. Harrison, attorney for and on behalf of the State of Indiana, Department of Insurance ("Department"), and Joshua A. Baldwin ("Respondent"), a licensed Indiana resident insurance producer holding license number 855989, to resolve all matters under Cause Number 13786-AG15-0420-107. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner, Indiana Department of Insurance.

WHEREAS, Respondent is a licensed resident insurance producer in the State of Indiana; and

WHEREAS, on or about February 5, 2015, the Department received a criminal misdemeanor chronological case summary from the Muncie City Court, for cause 18H01-1409-CM-02322. The case summary documented the filing of Operating a Vehicle While

Intoxicated - Endangering a Person, Operating a Vehicle with BAC .08% or More, and Improper Turn at Intersection, against the Respondent on September 24, 2014. On September 29, 2014, Respondent's attorney filed a written appearance, waived the initial hearing, and entered a plea of not guilty on behalf of Respondent. On October 21, 2014, the Court accepted a Title 12 Deferral, stating upon successful completion of the terms of the order and the passage of one (1) year the cause of action will be dismissed; and

WHEREAS, IC-27-1-15.6-17(b) states that: Not more than thirty (30) days after an initial pretrial hearing date, a producer shall report to the commissioner any criminal prosecution of the producer initiated in any jurisdiction; and

WHEREAS, a review of Department records failed to show a notification of the criminal prosecution by Respondent; and

WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without a hearing;

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and Respondent in this administrative action.
2. This Agreed Entry is executed voluntarily by the parties.
3. Respondent voluntarily and freely waives his right to a public hearing on the issues in this action.
4. Respondent admits that he failed to report a criminal prosecution to the Commissioner, within thirty (30) days after an initial pretrial hearing date.


5. Respondent agrees to payment of a civil penalty in the amount of two hundred fifty dollars (\$250.00), payable by cashier's check or money order to the Indiana Department of Insurance within ninety (90) days from the date the Commissioner's Final Order is filed.
6. The Department agrees to accept Respondent's compliance with the terms of this Agreed Entry as full resolution of this matter.
7. Respondent is aware that his failure to comply with any of the terms of this agreement will result in the matter being set for hearing and may result in the permanent revocation of his Indiana insurance producer license and/or additional penalties.
8. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
9. Respondent has carefully read this agreement and fully understands and accepts its terms.
