**FINDINGS OF FACT AND SUSPENSION ORDER**

WHEREAS, Jason Christmas (“Respondent”) is a nonresident insurance producer under license # 848050.

WHEREAS, Indiana Code 27-1-15.6-12(g) states that a licensed producer must furnish the commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding within ten (10) days of a request.

WHEREAS, on March 13, 2015, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a certified letter requesting a list of appointments.

WHEREAS, on March 19, 2015, certified mail article # 9214 8901 0661 5400 0052 4790 10 was returned by the United States Postal Service (“USPS”) marked as return to sender.

WHEREAS, on April 20, 2015, the Commissioner resent the March 13, 2015 request for a list of appointments to Respondent via email to the email address [jgchristmas@gmail.com](mailto:jgchristmas@gmail.com), which is on record for Respondent.

WHEREAS, the April 20, 2015 email included a request for a "delivery receipt". A delivery receipt was received by the Department that same day, indicating that the email to Respondent was delivered successfully.

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days as required under Indiana Code 27-1-15.6-12(g).

WHEREAS, Indiana Code 27-1-15.6-12(h) provides that the commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 848050 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
