ADMINISTRATIVE ORDER
NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance, pursuant to Indiana Code § 4-21.5-1 *et seq.*, and Indiana Code § 27-1-15.6-12, hereby gives notice to Jamal Baldwin, (“Respondent”) of the following Administrative Order:

1. Respondent, a resident of Georgia, is a licensed insurance producer, holding license number 826472 since June 029, 2012 (“Respondent’s license”).
2. Respondent’s license will expire on June 30, 2015.
3. On or about May 19, 2015 the Enforcement Division was notified that Respondent’s nonresident license was revoked by the California Department of Insurance on May 10, 2015 for his failure to report other states actions and for demonstrating lack of fitness or trustworthiness.
4. The Department has learned that Respondent’s license was revoked in Kansas (January, 2013) and South Dakota (May, 2013).

5. Respondent did not disclose the Kansas license revocation to the Department in a timely manner.

6. Respondent's licenses were revoked in Kansas and South Dakota for demonstrating financial irresponsibility in the business of insurance.

7. Pursuant to Indiana Code § 27-1-15.6-12(b)(9), the Commissioner may refuse to issue or renew an insurance producer's license if the producer has had a producer's license, or its equivalent, denied, suspended, or revoked in any other jurisdiction.

8. Pursuant to Indiana Code § 27-1-15.6-17(a), a producer shall report to the commissioner any administrative action taken against the producer in another jurisdiction or by another governmental agency in Indiana not more than thirty (30) days after the final disposition of the matter.

9. Pursuant to Indiana Code § 27-1-15.6-12(b)(8), the Commissioner may refuse to issue or renew an insurance producer's license for using fraudulent, coercive, or dishonest practices, or demonstrating incompetence, untrustworthiness, or financial irresponsibility in the business of insurance.

10. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of the reason for the nonrenewal of his license. This Order serves as that notice.

11. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty three (63) days of receiving this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that **his license shall not be renewed.**
