FINAL ORDER



The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. The Commissioner hereby incorporates the Agreed Entry, attached, as if fully set forth herein, and approves and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner as follows:

1. Respondent's Indiana Non-Resident Independent Adjustor License, number 962692, is hereby permanently revoked.
2. The Department agrees to accept this agreement as full resolution of this matter.

AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Joshua Harrison, and Jeremy Smith ("Respondent"), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance.

WHEREAS, in July 2014, Respondent applied for and received a non-resident independent adjustor license; and,

WHEREAS, Indiana Code 27-1-28-18-(9) states the Commissioner may suspend, revoke, or refuse to issue or renew an independent adjustor license if the independent adjustor had an insurance license, or its equivalent, probated, suspended, revoked, or refused in another state, province, district, or territory; and,

WHEREAS, on September 1, 2015 Respondent had a license revoked in Wisconsin for forgery and misrepresentation of insurance product/policy; and,

WHEREAS, Indiana Code 27-1-28-22 requires that an independent adjuster shall report to the commissioner any administrative action taken by another jurisdiction within thirty (30) days; and,

WHEREAS, Respondent failed to notify the Indiana Department of Insurance of this license revocation within thirty (30) days; and,

WHEREAS, Indiana Code 27-1-28-18(10) states the Commissioner may suspend, revoke, or refuse to issue or renew an independent adjustor license if the independent adjustor has forged another person's name to a document related to an insurance transaction; and,

WHEREAS, on November 1, 2013 Respondent been terminated for cause for fabricating and creating new insurance policies on existing customers; and

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the Parties.
3. Respondent voluntarily and freely waives the right to a public hearing on this matter.
4. Respondent voluntarily and freely waives the right to judicial review of this agreement and the Commissioner's Final Order.
5. Respondent's license shall be permanently revoked, effective the day the Commissioner adopts this Agreed Entry via Final Order.

6. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
7. Respondent has carefully read this agreement and fully understands and accepts its terms.
