FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Meghan Whipp (“Respondent”) is a nonresident insurance producer under license number 992682;

WHEREAS, Indiana Code § 27-1-15.6-8(f) states that a nonresident producer who receives a nonresident producer license shall maintain licensure in good standing in the nonresident producer’s home state;

WHEREAS, Indiana Code § 27-1-15.6-8(b) states that the Commissioner of the Indiana Department of Insurance (“Commissioner”) may verify a producer’s licensing status through the Producer Database maintained by the National Association of Insurance Commissioners (“NAIC”) and its affiliates or subsidiaries;

WHEREAS, the Commissioner verified through the Producer Database maintained by the NAIC that Respondent’s producer license in her home state of Ohio was revoked because on or about March 17, 2015, Respondent pled guilty to misdemeanor theft. The Ohio Department of Insurance also discovered that Respondent had provided incorrect, misleading, incomplete, or


materially untrue information on her October 15, 2014 resident producer license application when Respondent answered "No" to a question asking if she had ever been convicted of a misdemeanor. On or about March 30, 1998, Respondent was convicted of misdemeanor Prohibition, Falsification and Obstructing Official Business;

WHEREAS, Respondent's producer license in her home state of Ohio is no longer in effect as required under Indiana Code § 27-1-15.6-8(f);

WHEREAS, Indiana Code § 27-1-15.6-8(g) provides that the Commissioner may, without a hearing and in his sole discretion, suspend any Indiana insurance producer license held by the nonresident producer until the Commissioner receives notice from the nonresident producer's home state that the home state license is in effect.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 992682 is hereby suspended, effective immediately, and will remain suspended until the Commissioner receives notice from Respondent's home state that her home state license is in effect.
