**FINDINGS OF FACT AND SUSPENSION ORDER**

WHEREAS, on September 21, 2005, the Indiana Department of Insurance Consumer Protection Division ("Division") received notification from the NAIC (National Association of Insurance Commissioners) that Margaret I. Archer ("Respondent") was the subject of a disciplinary action concerning her insurance license in the state of Georgia, effective July 25, 2005. *See Exhibit "A" attached hereto.*

WHEREAS, on October 14, 2005, the Division sent a letter by certified mail to Respondent advising her that she had failed to notify the Department of the Georgia action within thirty (30) days. In the letter, the Division requested a list of Respondent's appointments within ten (10) days after her receipt of the letter and advised her that failure to submit the list of appointments would result in the suspension of her Indiana non-resident insurance producer license. *See Exhibit "B" attached hereto.*

WHEREAS, the October 14, 2005 certified letter was signed for on October 19, 2005. *See Exhibit "C" attached hereto.*

*\$250 fine for failure to report*


WHEREAS, to date, Respondent has failed to submit her list of appointments and more than ten (10) days have elapsed since her receipt of the October 14, 2005 letter.

WHEREAS, Respondent's failure to submit her list of appointments within ten (10) days, as requested by the Division, is a violation of Indiana Code § 27-1-15.6-12(g).

WHEREAS, the Commissioner has the authority to issue an order suspending Respondent's license without a hearing pending receipt of said list of appointments, pursuant to Indiana Code § 27-1-15.6-12(h).

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license, number 412955, is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Division.
