**FINDINGS OF FACT AND SUSPENSION ORDER**

WHEREAS, on March 7, 2007, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Steven Vernick ("Respondent") a certified letter requesting a list of company appointments and a written response to a complaint received by the Department.

WHEREAS, on March 14, 2007, certified mail article #7004 1160 0000 3841 6920 was signed for by Respondent.

WHEREAS, Respondent has failed to provide a list of company appointments within ten (10) days as requested by the Commissioner.


WHEREAS, Respondent's failure to provide said list constitutes a violation of IC 27-1-15.6-12(g).

WHEREAS, the Commissioner has the authority to issue an order suspending Respondent's license without a hearing pending receipt of said list of appointments pursuant to IC 27-1-15.6-12(g).

WHEREAS, the Commissioner shall set this matter for hearing upon request of Respondent pursuant to IC 4-21.5-4-4.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 2110020 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments and response requested by the Commissioner.
