FINAL ORDER AND APPROVAL



2. Respondent to comply with all aspects of the spirit and letter of Indiana Insurance Code.

AGREED ENTRY

This Agreed Entry is entered into by Laura A. Willett, Attorney for and on behalf of the State of Indiana, Department of Insurance ("Department"), and Jeffrey Catron ("Respondent"), an insurance agency licensed to do business in the State of Indiana, to resolve all matters in the administrative action commenced by the Department under Enforcement Cause Number 6235-AG08-0326-090. This Agreed Entry is subject to the review and approval of James Atterholt, Commissioner for the Indiana Department of Insurance;

WHEREAS, Respondent is an insurance agent licensed to do business in the State of Indiana, holding License Number 499711; and

WHEREAS, the Department commenced an investigation of Respondent on October 10, 2007 after receiving a complaint regarding Respondent's sales practices; and

WHEREAS, the Department commenced this proceeding on the basis that such practice allegedly violated Indiana Code § 27-1-15.6-, and § 27-1-15.6-4; and

WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without the necessity of an administrative hearing.

IT IS THEREFORE NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Respondent in this administrative action.

2. This Agreed Entry is executed voluntarily by the parties. Respondent voluntarily and freely waives his right to a public hearing on this matter.

3. Respondent voluntarily and freely waives his right to petition for judicial review of this Agreed Entry and the Commissioner's Final Order.

4. Respondent agrees to pay a fine in the amount of two hundred and fifty dollars (\$250.00). The fine will be due within thirty (30) days from the date the Commissioner signs the Final Order in this matter.

5. Respondent has agreed to, and has received, additional training from Pennsylvania Life Insurance Company to help him better understand and comply with spirit and letter of Indiana Insurance Code.


6. Respondent agrees to comply with all aspects of the spirit and letter of Indiana Insurance Code.

7. The Department agrees to accept Respondent's compliance with the terms of this Agreed Entry as full resolution of this matter.

8. Respondent is aware that failure to comply with any terms of this Agreed Entry will result in the matter being set for hearing.


9. Respondent has carefully read this Agreed Entry and fully understands and accepts its terms.


