

AGREED ENTRY

This Agreed Entry is entered into by Kathy Carr Hulbert, Attorney for and on behalf of the State of Indiana, Department of Insurance ("Department"), and Tamara J. Koontz, formerly known and licensed as Tamara J. Shoup ("Respondent"), an un- licensed resident acting as a Marketing Representative insurance producer in Indiana for the period of April 30, 2006 to May 22, 2008 in violation of IC 27-1-15.6-3, to resolve all matters under Cause Number 6693-AG08-1112-276. This Agreed Entry is subject to the review and approval of James Atterholt, Commissioner of the Indiana Department of Insurance.

WHEREAS, Respondent was an unlicensed insurance producer in the State of Indiana for the period from April 30, 2006 to May 22, 2008; and

WHEREAS, the Department and Respondent desire to resolve their differences and settle the issues without a hearing;

IT IS THEREFORE NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Respondent in this administrative action.
2. This Agreed Entry is executed voluntarily by the parties.

3. Respondent voluntarily and freely waives its right to a public hearing on the issues in this action.
4. Respondent waives its right for a judicial review of this matter.
5. Respondent agrees to pay a civil penalty of Two Hundred and Fifty Dollars and No Cents (\$250.00) within twenty days (20) of the signing of the Commissioner's Final Order for non-compliance with the Indiana insurance producer licensing statutes.
6. The Department agrees to accept Respondent's compliance with the terms of this Agreed Entry as full resolution of this matter.
